March 7th Climate Smart *Meetup*: Eliminate Plastic Pollution – Let's Create a Wave of Change!

Our monthly New Paltz Climate Smart Solutions Meetup seeks to offer ideas to individuals as to how they can be part of the solution through lifestyle changes that help mitigate and adapt to the climate crisis. This month we are again focusing on the plastic problem because plastic production and disposal is a climate issue on every level.

We have invited Suzette Munley from Beyond Plastics to bring us up to date on what we as individuals can do. It will take changes at every level of our economy and civil life to stem the tide of plastic pollution. Individuals need to be moved to act in their personal lives and take action as part of a growing movement; corporations need to feel the pressure to initiate changes in their purchasing and packaging habits; governments need to impose bans and adopt laws that require extended producer responsibility; and new manufacturing of plastic must be prevented from spreading. Beyond Plastics seeks to educate the media, policymakers, and the public on the plastic pollution crisis; encourage businesses to eliminate single-use plastics; train people to become leaders in the anti-plastics movement; and help block new plastic manufacturing and plastic burning facilities.



Suzette Munley has been a restaurateur for 20+ years in Philadelphia, where she had a front-row view of the growing presence of plastic in the hospitality industry. As Chief Operating Officer, she was able to steer her own business away from this path and onto more sustainable methods. She developed a Waste Reduction Program centered on reuse and collaborated with suppliers to reduce plastic packaging. Currently, Suzette serves as Board President of the Center City Business Association. She also serves on the Board of PennFuture working to transition Pennsylvania to a clean energy economy and is a certified Climate Reality Leader. In 2022, Suzette completed Beyond Plastics' Plastic Pollution course, after which she activated her township Environmental Advisory Council to introduce a single-use plastic bag ban and joined forces with a coalition of 30+ townships driving bans across Pennsylvania. She became a part of the Volunteer Speakers' Bureau as a next step in education and outreach.

Climate Restoration - The Only Future That Will Sustain the Human Race

People around the world recognize the dire threat posed by climate change. Governments, businesses, and individuals are making commitments to shift to renewable energy sources, trim consumption, and otherwise reduce their carbon footprints. But what if these steps are woefully inadequate to ensure future health, or even the survival of the human race? What if the most popular goal being pursued by today's climate activists -net zero carbon emissions- is actually a recipe for human disaster?

That's the warning being sounded by scientist, engineer, and entrepreneur Peter Fiekowsky . . . along with an urgent call to refocus our rescue efforts on a much bigger, bolder, yet fully achievable goal-the goal of *restoring the climate* to a healthy state that will allow human beings to thrive.

Scientific data show that humans evolved and thrived in a world where atmospheric CO2 levels were below 300 parts per million (ppm). Meeting the goal of net zero emissions will leave us with a dangerous level of about 460 ppm. We need to do much better to return the world to climate conditions that we *know* are healthy for humans.

As Fiekowsky explains in *Climate Restoration*, this will require removing a trillion tons of excess CO2 from the atmosphere. The good news is that this task, while enormous and technically challenging, is eminently feasible. Scientists and engineers have developed four major technologies for greenhouse gas removal and storage: *Ocean iron fertilization; synthetic limestone manufacture; seaweed permaculture; and methane oxidation.*


Fiekowsky argues that these technologies are safe and practical and, even more remarkable, that they require little if any government funding since they can be financed largely through existing markets. For these reasons, they have enormous promise as vehicles for achieving climate restoration.

With the global climate crisis continuing to spiral out of control, the time for tough conversations about what it will *really* take to create a healthy future for humanity is here. *Climate Restoration* will surely inspire a lively book club conversation!

Battery Energy Storage System (BESS) Task Force

On Thursday, March 2nd at the New Paltz Town Board Meeting, Joe Londa (New Paltz Climate Smart Task Force member) will be presenting "Introduction of Battery Energy Storage Systems to the Town of New Paltz" which will give a quick overview of Battery Energy Storage Systems (BESS) and the proposed laws and process to regulate them in the Town of New Paltz. These proposed law changes and processes for Battery Energy Storage System installations have been reviewed by the Building Inspector and revised per her input. If passed, the Town of New Paltz will now have a consolidated Permit Application for Solar PV and/or Batteries (Tier 1 only) for Single Family, Multi-Family, and Commercial structures, updates to the New Paltz Code 140 which defines the criteria the Building Inspector will use to waive the need for a Site Plan Review, and updates to the Code accounting for word usage and definitions for BESS and the Permitted Uses by Tier 1 and 2.


