- **4. Meet John Gotto:** Potential CWOSP Commission member John Gotto said it was his personal interest in the environment and outdoor activities that led him to settle in New Paltz, and also attracts him to be involved in the work of the Commission. A conversation followed, in which the basic function and history of the CWOSP Commission, Open Space Plan and Open Space Bond approval, and progress on the Mill Brook Preserve were discussed. **Motion:** Seth McKee moved that we recommend to the Town Board that John be appointed to the CWOSP Commission. Brad Barclay seconded the motion. All present voted in favor.
- **5. Review & Approve Minutes February 11, 2015 Meeting:** It was noted that a line from the December minutes had been left in place when they were used as a template for the February minutes. That line was struck out. Seth McKee moved to accept the February minutes as amended. Richard Fiesel seconded the Motion. All present voted in favor.

6. Possible Land Acquisition - Update:

All present voted in favor. 7. Mill Brook Preserve Plan - Next Steps:

- **1. Public information session-** Alternative ways to get information out to the public were discussed.
- **1. Joint with Village -** The Plan has been officially adopted by both the Village and the Town. Both should be involved.
- **2.** @ **Village Board Room-** Jason West has assured Marty that the Village's large meeting room can be made available when a meeting is scheduled.
- **2. Seeking Funding** The ensuing discussion touched on the \$75,000 budget for the Preserve-- could it be fleshed out more? Tahawus Trails not only builds trails but offers consulting and planning services. Ulster County-- a source of funding? the County is working on an Open Space Plan and trails are important. The Community Foundation and the Nyquist Foundation might be applied to for some funding.

Seth McKee will get Kevin Borden together with Julie Lillis so they can brainstorm on how to start moving the plan along. It was asked if we have a good enough map to help plan access. We do have survey maps of the Sunset Ridge Property. Applications for grants to get funding must be made.

- **8. Village's Wallkill River Task Force:** Marty Irwin gave an update on the **Future of the Wallkill River-** conference to be held April 16th at SUNY. The scope of the Task Force is to be from the Wallkill's confluence with Rondout Creek upstream to Orange County. The goal is to make the river swimmable. Signs will be put up advising people with compromised immune systems not to swim in the river. Jason West is contacting other towns with a resolution that they can adopt to improve the river-- he is reaching out to five towns in Ulster County, four towns in Orange County, and one in Sullivan County.
- **9. Recruitment John Gotto:** Done in item 4, above.
- 10. Web Site Updates and additions: Not discussed due to absence of Dennis Moore.
- **11. WIFI in Community Building:** There is WIFI in the Community Center. The Log In is CommCenter [note caps]. We can access the internet on our laptops and mobile devices.
- **12. Other Old Business:** Lynn Bowdery asked on behalf of the Wallkill Valley Land Trust whether WVLT's proposed stewardship voucher for Jan-June 2015 had been approved. Marty Irwin said he would follow up on that.
