- 1. Update on Arbuckle designation (D. Gilmour)—will be completing next step in process
- 2. Grant status—J. Orfitelli will update at November meeting
- 3. Mohonk Project (C. Sobel)--John Orfitelli and Caryn Sobel met with Glenn Hoagland, Eric Roth, and Bob Larsen. The Mohonk Preserve staff has made all resources available for the HPC to research and document the historic properties in the Foothills parcel for landmarking and for the interactive map. Possible expansion to include historic landscape components discussed with staff. Internship prospects being considered.
