Public Information Session-Parking on Butterville Road, 6:30 p.m. Public Hearing-Taliaferro Conservation Easement, 7:30 p.m. Public Hearing-2018 Preliminary Budget, 7:35 p.m. Special Police Commission Meeting, 7:40 p.m. Town Board Meeting, 7:45 p.m. November 2, 2017

Present: Supervisor Neil Bettez, Councilman Dan Torres, Councilman Marty Irwin. **Absent**: Councilwoman Julie Seyfert-Lillis, Councilman Jeff Logan.

At 6:42 p.m. a motion was made by Supervisor Bettez to open the public information meeting. Seconded by Councilman Irwin, all aye votes cast, motion carried.

At 6:43 p.m. Councilman Logan arrived.

Public Comment:

Jim Bacon, Butterville Road resident, indicated that he is not in favor of installing guiderails along Butterville Road. He suggested limiting parking in a reasonable way for a specific stretch of the road. He feels that Butterville is an important vista and it should stay uninterrupted.

At 6:46 p.m. Councilwoman Seyfert-Lillis arrived.

Supervisor Bettez indicated that the proposed installation of the wooden guiderails is being driven by responses to SEQRA questions that were raised by the Town's Planning Board for the Preserve's Foothills project. This proposal could potentially mitigate the environmental issues. He also indicated that the road is being damaged and there are safety issues, and the concern is that it will get worse.

Alison Nash, Prospect Street resident, feels that this is a community gem and that she won't be able to walk along the trails if the parking on Butterville is taken away. She hopes the Town can find a way to keep the parking.

Glenn Hoagland, Mohonk Preserve, indicated that they have taken into account the concerns expressed by the neighbors, the Town Highway Superintendent and the Police Chief. As part of Mohonk's Foothills project, work on a 100 space off-road parking lot has been approved by the Planning Board and is scheduled to begin in 2018, pending funding. As specified by the Planning Board, as part of the Testimonial Gateway project, guiderails should be installed on roadside property along the borders of Gatehouse and Butterville Roads for safety and to limit roadside parking at undesirable locations that impact neighbors. Any guiderails that would be installed would be on Town land, and would require the Town to accept the guiderails on dedication and indemnify the Preserve.

David Porter and Nancy Schniedewind requested allowing parking on Butterville to remain until the larger parking lot is available.

Ron Knapp, Mohonk Preserve, indicated that it was a long and expensive process to get the approval for the parking lot at Gatehouse. He also said it was very complicated because there were a lot of factors.

Tom Sarantonio, Art Professor at SUNY, indicated that he's been painting the Foothills for 30 years. Access is important to him for many reasons. He doesn't feel that the parking along Butterville is unsafe, but suggested restricting parking on the weekends when it is busiest.

David Brownstein indicated that he is not in favor of taking access away.

Written comments were submitted by David Nightingale, Lee Bell, Lisa Chason, Misha Harnick, all of which are not in favor of taking parking access away on Butterville Road.

Public Hearing-Taliaferro Conservation Easement

At 7:44 p.m. the Public Hearing on the proposed Taliaferro Easement was opened.

Public Comment:

Christie DeBoer, Executive Director of the Wallkill Valley Land Trust and Keri Watkins Bates from Scenic Hudson spoke in favor of the proposed Taliaferro Easement. They indicated that a publicprivate partnership is sought to purchase a permanent conservation restriction on the farm that will protect the land from future non-agricultural development.

Carol and Ted Cryer and David Brownstein spoke in favor of the proposed easement.

Supervisor Bettez indicated that the Board will take action on this at the November 16th meeting.

At 7:51 p.m. a motion was made by Supervisor Bettez to close the public hearing. Seconded by Councilman Logan, all aye votes cast, motion carried.

WHEREAS, in July 2016, as authorized, the Village of New Paltz (the "Village") in collaboration with the Town to New Paltz (the "Town") jointly applied to the New York State Office of Parks, Recreation and Historic Preservation ("OPRHP") for Environmental Protection Fund grant resources; and

WHEREAS, on December 8, 2016 the Village was awarded grant for 'Mill Brook Preserve Development' Project (the "Project"), Number EPF15603, in the amount of \$317,997; and

WHEREAS, the Project will leverage a program of public recreation and trail improvements on Village and Town-owned lands within Mill Brook Preserve, including but not limited to, providing funding for the development of an observation platform, educational panels, two bicycle path bridges (in conjunction with a planned +/- 0.75 mile bike path), a half-mile long universally accessible trail, as well as an information kiosk, trailhead and parking area by Sunset Ridge Road, plus the underwriting of materials purchases for the construction of bog bridges and pedestrian foot bridges along primitive hiking trails; and

WHEREAS, for the purposes of the development and implementation of the Project and in order to receive the grant funding, OPRHP requires that the Village serve as the contracting party and that the Town assumes the role of contract guarantor, to wit: that as co-owner of the property, the Town will allow the Project work to be performed; and

WHEREAS, the Village Board and the Town Board continue to believe that the preservation of natural resources, and open space, benefits and serves the public and has concluded that accepting the aforesaid grant for the Project under the terms required by OPRHC advances said goals,

NOW THEREFORE, IT IS HEREBY RESOLVED, that subject to all required participation and cooperation by the Village of New Paltz, the Town of New Paltz, hereby accepts the grant award from New York State OPRHP in accordance with provisions of Title 9 of the Environmental Protection Act of 1993, for the amount of \$317,997 for the Mill Brook Preserve Development' Project, Project Number EPF15603, and it is further

RESOLVED, that the Supervisor, or Deputy Supervisor, as the case may be, is hereby authorized and directed to execute and deliver any and all contract documents and related documents, between the Village, Town and NYS OPRHP, or any other governmental agency, including, but not limited to, the master contract for the aforementioned grant program, subject to review and approval by the Village Attorney and by the attorney for the Town; and it is further

RESOLVED, that upon execution and delivery of the required contract documentation, the Supervisor, or his designees, are hereby authorized and directed to act consistent with the Town's role as contract guarantor with respect to the grant award for the specific purposes set forth herein.

Seconded by Councilman Torres, all aye votes cast. Councilwoman Seyfert-Lillis was not present during the vote or discussion. Motion carried.
