Agenda:

Appointments:

A motion was made by Supervisor Bettez to approve the hiring of Sarah Nieves as a part-time dispatcher with the New Paltz Police Department. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Letter of Support:

A motion was made by Supervisor Bettez to authorize the Supervisor to sign the Letter of Support for Historic Huguenot Street's application to the New York State Thruway's Logo Signs Program on behalf of the Town, with amended language regarding the Town's records. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Comments regarding Councilman Logan's service:

Councilman Irwin indicated that it was important to recognize Councilman Logan's service to the Town and thank him for his hard work.

Rte. 299 Gateway Committee Draft Report:

Supervisor Bettez indicated that a draft report has been created by the Committee. Councilman Torres indicated that he is very excited about the report and that it addresses many of the questions that have been raised over the years relative to the Master Plan. Councilwoman Seyfert-Lillis indicated that it is an excellent report and that she is also excited for it. Supervisor Bettez indicated that the Committee will present the report to the Town Board and Planning Board, possibly at a joint meeting in January. Councilman Irwin expressed his concern regarding recommendations to properties along the thruway and the possibility of there being challenges to those recommendations. The Board encouraged people to read the report and come to the presentation.

Moratorium Update:
