#### Police Citizen's Advisory Committee Resolution Amendment:

# A motion was made by Supervisor Bettez to approve the following proposed amendment to the resolution:

BE IT RESOLVED, that the Town Board of the Town of New Paltz, Ulster County, New York, hereby establishes a Police Citizens' Advisory Committee. Said Committee will be comprised of five members, who shall be appointed by the Town Board and will serve at the pleasure of the Town Board. A chairperson, appointed by the Town Board, will preside over all meetings of the committee, and will serve at the pleasure of the Town Board. The Committee's function is to hear and review investigations of all citizen complaints regarding Police Department members and operations, and to facilitate communication between the Department and the public. After their review, they will report their findings in an open meeting for public record and transparency, and make an advisory opinion to the Police Commission. If there are any decisions regarding an investigation that are not agreed upon with the investigating agent, the Committee Chair shall present the concerns to the Police Commission. The Police Commission, after review of the investigation, will make the final decision. The Committee shall be established upon passage of this resolution. Seconded by Councilman Irwin, all aye votes cast, motion carried.
