## **Resolution-Empire State Trail:**

A motion was made by Councilman Torres to adopt the following resolution:

**WHEREAS**, the New York State Department of Transportation proposes the construction, reconstruction, or improvement of the Empire State Trail-State Highway 1536/New York Route 299: Hudson Valley Rail Trail in the Town of New Paltz located in Ulster County, PIN 881303.121, and

**WHEREAS**, the State will include as part of the construction, reconstruction, or improvement of the above mentioned project the relocation and adjustment to water mains and appurtenances, owned by the Town of New Paltz, pursuant to Section 10, subdivision 24, of the State Highway Law, as shown on the contract plans relating to the project and meeting the requirements of the owner, and

WHEREAS, the service life of the relocated or replaced utilities has not been extended, and

**WHEREAS**, the State will provide for the reconstruction of the above mentioned work, as shown on the contract plans relating to the above mentioned project.

#### NOW, THEREFORE,

**BE IT RESOLVED**: That the Town of New Paltz approved of the relocation of the adjustment to their water mains and appurtenances and the above mentioned work performed on the project and shown on the contract plans relating to the project and that the Town of New Paltz will maintain or cause to be maintained the adjusted facilities performed as above stated and as shown on the contract plans.

**BE IT FURTHER RESOLVED** that Neil Bettez, Town Supervisor has the authority to sign, with the concurrence of the Town Board, any and all documentation that may become necessary as a result of this project as it relates to the Town of New Paltz, and

**BE IT FURTHER RESOLVED**: That the clerk of the Town of New Paltz is hereby directed to transmit five (5) certified copies of the foregoing resolution to the New York State Department of Transportation. Seconded by Supervisor Bettez, all aye votes cast, motion carried.
