**6. Mill Brook Preserve:** Seth McKee has done the final editing of the Plan and it is ready to be approved by the CWOSP Commission and then by the Town Board. Seth mentioned that the access points to the Preserve might be an issue. Susan Zimet brought up the possibility that the present Town Hall property, which can connect with the Preserve, might be sold, and that keeping access points is an issue to keep in mind. Seth pointed out that the Plan can be implemented in phases, and that it needs a Friends Group to take on responsibility, possibly the EnCB. Maybe help from the NY-NJ Trail Conference. Susan Zimet said that Chris Marx, the Highway Superintendent, would like to create a Parks and Rec Department, with the proposed Wallkill View Farm Trail in mind. A menu of options would be useful to have. Seth said some of the maps in the Plan will have to be fixed. He suggested that we should take people on a tour to see what is there. He said there will also have to be some access easements. However, the goal for now is to get the Plan finalized.

**Motion:** Doug McBride moved that CWOSP Commission accept the Plan without further changes for submission to the DEC. The motion was seconded by Tom O'Dowd. All present voted in favor.

Seth said he will need help with the formatting. Dennis Moore said he will make it look pretty. The deadline for the DEC is the end of August, and it should be in before that to close out the grant.

The discussion turned to presenting the Plan to the Town Board. There need not be a special public meeting. Susan Zimet wants to keep it moving along and will set a date for a special meeting of the Town and Village Boards to present the Plan for their approval. Possibly on Thursday, September 4, at 7:30PM. Possibly then a Saturday or Sunday walk could be scheduled to show the public. Seth will check his calendar. John Warner knows the Preserve area very well- he should be invited.
