**I. Introduction:**

  - 10/12 Planning Board Meeting canceled.
  - 9/28 Planning Board Meeting: Agri-Business Child Development (ABCD) wants to expand play areas outside, but didn't have specific plans submitted yet; given federal grant

- Riparian Buffer Assessment: Cornell Cooperative (CSC) wants more information about potential CEA sites. Right now, there is just the Wallkill site. The group looked at four focus areas, and ENCB members were asked for their comments.

**IV. Other Groups of Interest to the EnCB:**

- Ulster County Environmental Management Council Meeting
  - Meeting consisted mostly of a big presentation by James W. Taylor of Taylor Biomass (facility going in, in Montgomery). A waste stream that comes into Montgomery is about 10% unrecognizable items, 23% inorganic waste that could be recyclable, 2% household hazardous waste, and 65% organic waste (biomass- paper, cardboard, etc.). Taylor proposes

- to put these things into a giant incinerator and generate a gas they can use for fuel.
  - Mentioned a program run by Scenic Hudson called “How To Go Solar Now,” a program where you can learn how to cite solar facilities in your town.
  - Water Quality Coordinating Committee: Had a meeting today and talked about putting together a stormwater coalition. The committee wants this for the county, and is aware that there are funds available from the Hudson Valley Regional Council for this.
- Village EPB and Solar Landfill Update:
  - Environmental Policy Board: received a draft of an environmental impact statement available for public comment; 11/9 at 7pm is the public hearing/opening for this. Comments will be accepted until 11/24. We will draft something at the next meeting and then submit it.
  - Still have one vacancy.
