## Pledge of Allegiance

- 1. Public Comment: No public comments were received.
- Review/Approve October Minutes: The Commission reviewed and approved <u>minutes from</u> <u>our meeting on October 16<sup>th</sup></u> as amended and John Orfitelli agreed to post.
- 3. **Historic Landmark Preservation Legislation:** A <u>Community Preservation Fund Workshop</u> organized by The Trust for Public Land and Scenic Hudson was held on November 14<sup>th</sup>. Neil Bettez, New Paltz Town Supervisor attended. Carli Fraccarolli, Advocacy Associate, Scenic Hudson, Inc., provided this follow up to the workshop:

A workshop has been scheduled for December 12<sup>th</sup> in the Community room for members of the Environmental Conservation Board, Clean Water and Open Space Preservation Committee, and Historic Preservation Commission to outline the work scope and timeline required to bring this legislation to the public in a referendum slated for the 2020 ballot.

- 4. **Road Side Markers:** John Orfitelli contacted John Sorlie, Assistant Vice President, and Branch Manager, Riverside Bank to request funding for the Lent House marker. The telecon was documented in a 10/3 email to John Sorlie who has been very positive about our request. John is expecting a response from his management very shortly.
- 5. Social Media for New Paltz Preservation: Dawn Elliott agreed to create a Facebook page for the HPC. Each Commissioner with have admin authority to add material to the page. The use of Facebook and Instagram will prove very important to obtaining support within the community for passage of a referendum in 2020 for the preservation law. John Orfitelli agreed to transform the 'Then and Now' Shockwave files into video format to facilities viewing in Facebook.
- 6. Other: John Orfitelli provided a <u>letter of support of the Town of New Paltz application for a New York State Hudson River Greenway Planning Grant</u>, November 7, 2019. The Town intends to use the requested funding for the preparation of a revised and updated Open Space Plan, with the goal of guiding and facilitating our continuing efforts to preserve and protect open space resources.

Motion to adjourn was made by Susan DeMark and seconded by Matt Maley. Motion carried. Meeting adjourned at 8:30pm.
