

RESOLUTION

(ELTING MEMORIAL LIBRARY - 2017)

At a regular meeting of the Town Board of the Town of New Paltz, Ulster County, New York, held at the Town Hall, in New Paltz, New York, in said Town on the ____ day of September 2017, at 7:30 o'clock P.M., Prevailing time.

The following resolution was offered by _____ who moved its adoption, seconded by _____, to wit:

WHEREAS, there has been filed in Office of the Town Clerk, Town of New Paltz on September 1, 2017 a petition pursuant to Section 259, subdivision 1,b (1) of the Education Law of the State of New York by the Board of Trustees of the Elting Memorial Library requesting that the following question be placed upon the ballot and voted on at the next general election of the Town of New Paltz to be held on Tuesday, November 7, 2017:

“SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF NEW PALTZ FOR THE OPERATING BUDGET OF THE ELTING MEMORIAL LIBRARY BE INCREASED BY NINETY THOUSAND DOLLARS (\$90,000) TO THE SUM OF FIVE HUNDRED AND FIFTY-SIX THOUSAND DOLLARS (\$556,000) ANNUALLY”

NOW, THEREFORE, BE IT RESOLVED pursuant to Section 81 of the Town Law of the State of New York that the following question shall be voted on at the next general election of the Town of New Paltz to be held on November 7, 2017:

“SHALL THE ANNUAL CONTRIBUTION OF THE TOWN OF NEW PALTZ FOR THE OPERATING BUDGET OF THE ELTING MEMORIAL LIBRARY BE INCREASED BY NINETY THOUSAND DOLLARS (\$90,000) TO THE SUM OF FIVE HUNDRED AND FIFTY-SIX THOUSAND DOLLARS (\$556,000) ANNUALLY”
