WHEREAS, a Local Law to Repeal Article VII, “Grievance Day for Real Property Assessment Review” of Chapter 127, “Taxation” of the Code of the Town of New Paltz was introduced at this meeting as follows:

WHEREAS, the effect of the adoption of such local law would be to repeal the town’s previous local option with respect to the conduct of “Grievance Day” to meet and hear complaints in relation to real property assessments and thereby provide that “Grievance Day” for such purpose will be held on

the fourth Tuesday of May as provided for pursuant to the provisions of subdivision 1 of §512 of the New York State Real Property Tax Law; and

WHEREAS, the Town Board of the Town of New Paltz is hereby designated lead agency for the purpose of determining the environmental impact of the action described in said local law and to make all determinations pursuant to the State Environmental Quality Review Act (SEQR);

WHEREAS, this Board desires to hold a public hearing with respect to the adoption of the aforesaid local law;

NOW, THEREFORE, BE IT RESOLVED that a public hearing will be held by the Board with respect to the adoption of the aforesaid local law, at the Town Hall on the _____ day of _____, 2016, at _____ P.M.; and it is further
