Re: School Area Speed Reduction - South Putt Corners Road

Supervisor Bettez,

As part of County Executive Hein's ongoing commitment to traffic safety throughout Ulster County, the Ulster County Department of Public Works (UCDPW) is requesting support for the study and establishment of a regulated School Zone and associated lower speed limit near the New Paltz High School. Currently the posted speed limit for South Putt Corners Road in this area is 45 MPH.

It is anticipated that the establishment of a regulated school zone will allow for the speed limit to be reduced 10 MPH below the current posted speed limit. It is believed that the reduction of the speed limit will help ensure the safety of students and the travelling public in general. UCDPW intends to install solar powered driver feedback signs that will alert drivers to their speeds using active radar technology. These signs will be installed and maintained by Ulster County at no cost to the Town.

I ask that you provide my office a return letter in support of the lowering of the posted speed limit, along with an adopted Town resolution requesting the NYSDOT to conduct a speed study for the school zone as well as a completed TE-9a form. Enclosed are samples of the requested materials for your use.

Additionally, enclosed is a copy of a letter I have sent to Superintendent Maria C. Rice requesting a letter in support of these efforts to be sent to your attention to be included with the materials that my office will process and provide to NYSDOT.
