WHEREAS, proposed Local Law No. __, 2019 to replace Article II, “Snow and Ice Removal” of Chapter 118, “Streets and Sidewalks” of the Code of the Town of New Paltz was introduced at a meeting of the Town Board of the Town of New Paltz, County of Ulster, State of New York, on the ____ day of _____, 2019, with a copy thereof having been duly given to all council members, the intent and purpose of which is to provide for the removal of snow and ice from sidewalks and other walkways in the Town of New Paltz lying outside the boundaries of the incorporated Village of New Paltz within twelve (12) hours of the cessation of accumulations of snow and ice and to provide penalties for non-compliance with such local law, including the addition to owners’ real property tax bills of costs and expenses incurred by the town in the removal of such accumulations of snow and ice; and

WHEREAS, due notice of a public hearing to be held thereon on the _____ day

of _____, 2019, was duly published in the "Daily Freeman," a newspaper printed and published in New Paltz, Ulster County, New York, commencing on the ____ day of _____, 2019; and

WHEREAS, due and proper notice of such proposed local law and of the public hearing to be held thereon as aforesaid was given pursuant to all applicable laws, rules and regulations regarding the giving of such notice; and

WHEREAS, such public hearing was held thereon on the _____ day of _____, 2019, at which time all interested persons were given an opportunity to be heard thereon;

NOW, THEREFORE, BE IT RESOLVED that the Town of New Paltz adopt a certain local law entitled, "A Local Law to Amend the Code of the Town of New Paltz to add a new Chapter 119, "Parking, Stopping and Standing of Vehicles."
