

## NOTICE CONCERNING LEAD AGENCY

The Town of New Paltz Town Board, in accordance with Article 8 of the State Environmental Conservation Law, gives Notice as follows:

1. The Town Board proposes to purchase and develop 59 North Putt Corners Road, utilizing the existing warehouse structure, for the Town's Police Department and Justice Court. The parcel contains 14.3 acres, known as Section 86.8, Block 6, Lot 21 on the Town tax maps, located with frontage along North Putt Corners Road within the Town of New Paltz in Ulster County, New York.
2. The Town Board has made the following findings:
  - (a) The proposed action is subject to the State Environmental Quality Review Act.
  - (b) The action may involve one or more other agencies.
  - (c) The action is preliminarily classified as an Unlisted action pursuant to 6 NYCRR Part 617.
  - (d) Coordinated review of the action is appropriate.
3. The Town of New Paltz Town Board shall be designated as Lead Agency if no objection to such Lead Agency status is received by the Town Board from any other involved agency within thirty calendar days of mailing this notice to such agencies. All involved and interested agencies are as follows:
