

CONTRACT WITH FAMILY OF WOODSTOCK 2015

AGREEMENT made as of the \_\_\_ day of\_\_\_\_ 2015 by and between the TOWN OF NEW PALTZ, a municipal corporation, with offices at 1 Veterans Dr., New Paltz, New York, hereinafter referred to as “TOWN”, and FAMILY OF WOODSTOCK, INC., a not-for-profit corporation, P.O. Box 3516, Kingston, New York, hereinafter referred to as “FAMILY”.

W I T N E S S E T H:

WHEREAS, the Town is committed to providing funds to Family of New Paltz for emergency and human services for the residents of the TOWN OF NEW PALTZ; and

WHEREAS, FAMILY is a not-for-profit corporation providing emergency 24-hour hotline services and walk-in services in normal business hours, emergency food, and emergency short-term substance abuse counseling, at their location within the Town of New Paltz, which is partially funded by federal program funds; and

WHEREAS, the Town has determined that these services are programs relating to the general welfare of the inhabitants of the Town of New Paltz, and eligible for contract with the Town under General Municipal Law, Section 99-h; and

WHEREAS, the TOWN has requested that FAMILY provide certain services, the parties agree as follows:

1. The FAMILY shall provide the residents of the TOWN OF NEW PALTZ with the following:

- a) Emergency food and clothing;
- b) 24 hour hotline service;
- c) Substance abuse counseling

2. Services shall be performed by FAMILY for the period January 1, 2015 through and including December 31, 2015.

3. In consideration of the aforesaid the TOWN shall pay FAMILY the sum of \$25,000.

4. FAMILY shall semi-annually submit to the TOWN written reports of service provided for and to the TOWN, and annually or more often, at the TOWN'S request, submit in person a Report of FAMILY'S activities.

5. FAMILY shall maintain third-party liability insurance, naming the TOWN as co-insured, in the minimum amount of \$1,000,000.00, and FAMILY, irrespective of said insurance, shall indemnify and hold the TOWN harmless from any and all claims, liabilities, damages, and judgments (including attorney's fees) arising from injury to persons or property in connection with the operation of this program.
