Summary Description of the Intent
of the
STORMWATER MANAGEMENT AND EROSION & SEDIMENT CONTROL LAW

The proposed "STORMWATER MANAGEMENT AND EROSION & SEDIMENT CONTROL", would add a new Chapter 135 to the Town Code for the purpose of establishing minimum stormwater management requirements and controls for land development activities and otherwise regulating stormwater to protect and safeguard the general health, safety, and welfare of the residents and property owners in the Town of New Paltz and to comply with the requirements of the DEC SPDES General Permit for Municipal Separate Storm Sewer Systems (GP-0-15-003).

The intent of the local law is to ensure land development activities incorporate DEC stormwater management practices and to encourage the use of supplemental stormwater management practices, with particular emphasis on Green Infrastructure practices, in order to protect surface water and groundwater resources by utilizing standard practices to manage stormwater discharges from land development activities to control stormwater discharge rates and volume, and to enhance and increase the water quality of stormwater discharges.

The action is anticipated to have a beneficial impact on surface water and groundwater resources and avoid or minimize the erosion of disturbed land. No adverse environmental impacts are anticipated.
