Summary Description of the Intent  
of the  
STORMWATER RELATED CODE AMENDMENTS LAW

The proposed "STORMWATER RELATED CODE AMENDMENTS", would amend Chapter 121, Subdivision Regulations, and Chapter 140, Zoning, to incorporate minimum stormwater management requirements and controls for land development activities and otherwise regulate stormwater to protect and safeguard the general health, safety, and welfare of the residents and property owners in the Town of New Paltz and to comply with the requirements of the NYS DEC SPDES General Permit for Municipal Separate Storm Sewer Systems (GP-0-15-003).

The action is anticipated to have a beneficial impact on surface water and groundwater resources by ensuring land use applications subject to Planning Board review utilize standard practices to manage stormwater discharges from land development activities, control the rate and volume of the stormwater discharges and enhance and increase the water quality of stormwater discharges, and that the Planning Board review incorporates appropriate standards for review of proposed stormwater management and water quality improvement practices. No adverse environmental impacts are anticipated.
