

## Town Board Meeting July 21, 2022, 7:00 p.m. Via Videoconference

**Present**: Supervisor Neil Bettez, Councilwoman Alex Baer, Councilwoman Esi Lewis, Councilman Dan Torres, Councilwoman Julie Seyfert-Lillis.

At 7:27 p.m. a motion was made by Supervisor Bettez to open the meeting with the pledge. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

### Agenda:

A motion was made by Supervisor Bettez to adopt the agenda as written. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### Announcement:

Supervisor Bettez announced the untimely passing of NP Police Officer Daniel Carpinelli. A moment of silence was observed.

### Public Input:

Gabriela O'Shea read a statement regarding the safety of Ulster County roads and trails. She urged the Town Board to apply for an Empire State Trail Planning Grant.

## Resolution-Mohonk Preserve Grant Application, Brook Farmhouse Project:

A motion was made by Supervisor Bettez to adopt the following resolution. Seconded by Councilwoman Lewis, all aye votes cast, motion carried.

#### RESOLUTION ENDORSING THE APPLICATION OF MOHONK PRESERVE, INC. FOR A GRANT UNDER THE ENVIRONMENTAL PROTECTION FUND FOR THE BROOK FARMHOUSE PROJECT

WHEREAS, the Mohonk Preserve, Inc. is applying to the New York State Office of Parks, Recreation and Historic Preservation (OPRHP) for a grant under the Environmental Protection Fund to be located at the Brook Farmhouse in the Mohonk Preserve Foothills, a site located within the territorial jurisdiction of this Town Board of New Paltz; and WHEREAS, as a requirement under the rules of these programs, said not-for profit corporation must obtain the "approval/endorsement of the governing body of the municipality in which the project will be located"; NOW, THEREFORE, BE IT RESOLVED THAT, subject to all applicable approvals and associated permit issuances, the Town Board of the Town of New Paltz hereby does support and endorse the application of Mohonk Preserve, Inc. for a grant under the Environmental Protection Fund known as The Brook Farmhouse Project and located within this community.

## **Discussion-Shared Services Proposal:**

The Town will be hiring the Assessor from Esopus and her Clerk as consultants, to be paid on an hourly basis.

# Shannon Harris Assessment Consulting Services Contract:

A motion was made by Supervisor Bettez to authorize the Supervisor to execute the contract based on the Scope of Work Agreement with Shannon Harris. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

# Proposal for Professional Services:

A motion was made by Supervisor Bettez to authorize the Supervisor to sign the contract for professional services related to the Preparation and Development of a Combined Water System Source Balancing Standard Operational Procedures (SOP) Manual and Commissioning Protocol by LaBella, PC. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

# <u>Resolution- "Idaho Stop":</u>

A motion was made by Supervisor Bettez to adopt the following resolution. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### RESOLUTION IN SUPPORT OF NEW YORK STATE BILLS A3104A/S920A (AKA "IDAHO STOP")

**Idaho Stop**: A person operating a bicycle approaching a stop sign shall slow down and, if required for safety, stop before entering the intersection. After slowing to a reasonable speed or stopping, the person shall yield the right-of-way to any vehicle and pedestrians if required, before proceeding. A person operating a bicycle approaching a steady red trafficcontrol signal shall stop before entering the intersection and shall yield to all other traffic. Once the person has stopped, the person may proceed through the steady red traffic-control signal with caution.

**WHEREAS,** the National Highway Traffic Safety Administration reported 846 bicyclists killed in crashes with motor vehicles in the U.S. in 2019—including 29 in New York, and

**WHEREAS,** a majority of these crashes occur at intersections, often involving cyclists "hooked" by turning vehicles, as well as when bike lanes are blocked, forcing cyclists into the path of traffic, and

**WHEREAS,** permitting cyclists discretion to proceed in the absence of cross-traffic will enable them to: clear intersections ahead of turning vehicles; exit vehicle "blind spots," and; establish visibility on the road ahead, and **WHEREAS,** the New York City Police Department wrote 35,000 moving violations to cyclists in 2019—more than for trucks which figured in 43 of that year's 220 road deaths, and

**WHEREAS,** the National Highway Traffic Safety Administration reported that 6,205 pedestrians were killed in crashes involving motor vehicles in 2019 vs. <u>none</u> involving bicycles, inferring that any increase in bicycle mode share would proportionally reduce pedestrian fatalities, and

**WHEREAS** cyclists in New York City have been allowed to proceed at red traffic signals during the "leading pedestrian interval" (thus emulating Idaho Stop behavior) since 2018 with no rise in complaints by motorists or pedestrians, and **WHEREAS** cyclists' exposure to tail pipe emissions is 4.3 times greater than car occupants and that the bill's passage would increase cyclists' distance from car exhaust, and

**WHEREAS** Idaho, which first passed such legislation in 1982, had the third fewest fatalities per 10,000 bicycle commuters in the U.S from 2011-2015—despite ranking 47th on federal funds spent on bike-walk improvements, and **WHEREAS** Delaware crashes involving bicycles at stop sign–controlled intersections fell 23% in the 30 months after it passed its Bicycle Friendly Act in 2017, and

**WHEREAS** NHTSA concluded in 2022 that bicycle stop-as-yield laws enhanced cyclist safety in states where they were evaluated, and

**WHEREAS** non-motorists pay half the cost of road construction and maintenance and are therefore entitled to proper infrastructure and enlightened legislation so they may safely share in its use, and

**WHEREAS** New York State has invested billions of dollars in bridges and extended bikeways, making cycling safer and easier on the public roads will increase throughput, maximizing the return on this investment, and grow the constituency for further improvements, and

**WHEREAS** bicycle tourism generates half a billion dollars per year in NY State and that NY City houses 800,000 active adult cyclists who comprise a ready market, and

**WHEREAS** allowing cyclists to yield-and-go at signed intersections will facilitate planners' use of secondary roads to create bike networks—further enhancing cyclists' safety, and

**WHEREAS** forty cycling organizations and fifteen state legislators have voiced support for this legislation, and **WHEREAS** passage of this legislation will enhance cyclist safety; extend resident access to green space; yield significant public health benefits; increase patronage of local business; and broadly enhance transportation connectivity, sustainability and resilience,

**NOW, THEREFORE, BE IT RESOLVED THAT** the Town of New Paltz calls on the New York State Assembly, Senate and the Governor to pass and sign into law A3104A/S920A (aka "Idaho Stop") to make cycling safer and easier across New York and to grow cycling as means of transportation, recreation and tourism, and

**THEREFORE BE IT FURTHER RESOLVED THAT** a copy of this Resolution be sent to Assembly Speaker Carl E. Heastie, Senate President Andrea Stewart-Cousins and Governor Kathy C. Hochul.

#### <u>Warrant</u>:

A motion was made by Supervisor Bettez to approve the July Warrant in the amount of \$1,363,593.48. Seconded by Councilman Torres, all aye votes cast, motion carried.

#### Authorization to execute contract:
