## Resolution- Preparation of Report by Joule Assets Inc. ("Joule"):

A motion was made by Supervisor Bettez to adopt the following resolution:

WHEREAS, it is the goal of the Town Board of the Town of New Paltz, Ulster County, New York, to adopt policies and undertake projects that reduce consumption of fossil fuels and greenhouse gas emissions, develop renewable energy, and that support New York State's Clean Energy Goals and Climate Leadership and Community Protection Act including without limitation opportunities to develop solar energy, and energy storage projects, and to support the Town of New Paltz's low to moderate income population; and

**WHEREAS**, New York State can support Municipal Solar and Storage Opportunities, including through grants from the New York State Energy Research and Development Authority ("NYSERDA"), tax credits and other incentives to the Municipality and its constituents; and

**WHEREAS**, the United States government can support Municipal Solar and Storage Opportunities through incentives to develop renewable energy projects and to support its LMI populations including through direct pay incentives, made available through the Inflation Reduction Act; and

**WHEREAS,** the Municipality and Joule Assets Inc. have entered into an agreement dated \_\_\_\_\_ pursuant to which Joule Assets Inc. is to provide certain energy-related services to the Municipality, and

**WHEREAS**, the Town of New Paltz and Joule each desire that Joule investigate and provide a report to the Municipality on the Municipal Solar and Storage Opportunities without charge or other obligation to the Municipality, and

**NOW THEREFORE**, **BE IT RESOLVED**, that the Town of New Paltz hereby authorizes Joule to investigate and prepare a report on the Municipal Solar and Storage Opportunities for presentation to the Board of New Paltz without charge or obligation to the Municipality.

Seconded by Councilman Torres, all aye votes cast, motion carried.

## Warrant:

A motion was made by Supervisor Bettez to approve the August Warrant in the amount of \$395,211.60. Seconded by Councilman Torres, all aye votes cast, motion carried.
