

# Public Hearing- "Trans-Hudson Petition to Extend Water & Sewer Districts" Public Hearing- "Shawangunk Ridge CEA" Town Board Meeting December 2, 2021, 7 p.m. Via Videoconference

**Present**: Supervisor Neil Bettez, Councilwoman Alex Baer, Councilwoman Julie Seyfert-Lillis **Absent**: Councilman Dan Torres, Councilman David Brownstein.

At 7 p.m. Supervisor Bettez opened the public hearing on the Trans-Hudson petition to extend water and sewer districts. The Town is still waiting for final approval from the Village. The Town is not taking any action tonight.

#### **Public Input:**

Don Kerr spoke in opposition of the petition.

At 7:04 p.m. Councilman Brownstein arrived.

#### Rose Rudnitski read the following letter in opposition of the petition:

"We, the undersigned New Paltz residents, are writing to express our opposition to the petition before you to expand a water district in order to include the Trans-Hudson site on the corner of Route 299 and North Putt Corners Road. As you know, Town Law § 194(2)(a) directs that if a town board determines it is "not in the public interest" to extend a district as requested, "the town board shall deny the petition."

With significant community participation and support, in 2019 the Town Board voted unanimously to rezone this area. The new zoning language explicitly endorses a widespread desire to "transition away from auto-oriented strip commercial development and extend the Village's walkable, mixed-use, 'Main Street' character into the Town." Bicycle-and pedestrian-oriented planning is an important component of this vision. Extending water service to enable a car-oriented, sprawl development, indeed one that has been repeatedly described as a "de facto Thruway rest stop," is antithetical to these goals.

Because this site plan includes dangerous features that would compromise the safety of the Empire State Trail users—the Route 299 driveway and an in-road bike lane on Route 299—it actually reduces existing bike-friendliness in this corridor. A plan that undermines public safety cannot be in the public interest. Ensuring the safety of Empire State Trail users should be your paramount concern.

Finally, the current site plan would clear a significant portion of the forested Thruway buffer required by the Town code. The integrity of this buffer matters to New Paltz residents. Left intact, it will more effectively minimize the Thruway's negative impacts on air quality and noise levels.

Denying this petition will encourage Trans-Hudson to put forward an improved design that matches community desires for this area as reflected in the 2019 zoning amendment. This new plan should prioritize bike and pedestrian safety while preserving the critical Thruway buffer. This board acted with foresight in 2019 when it voted to rezone this area. We urge you to do so again now by protecting the public interest and denying this petition. Sincerely,

### Barbara Goodman read the following letter in opposition of the petition:

"As a long-time resident of New Paltz, I am writing to urge you to deny the water petition sought for the proposed Mavis tire store, two fast food restaurants, and bank on the corner of Route 299 and North Putt Corners Road.

As a cyclist and someone who frequently drives through this intersection, I echo fears long expressed by the Bike-Pedestrian Committee that the current site plan would put Empire State Trail users in danger. Preliminary approval from the DOT should not be taken as proof that the design is adequately safe. As you know too well, the Village and Town have for years pleaded with the DOT for basic safety improvements such as lower speed limits and more crosswalks, rarely with any success. I encourage you to take a close look at the proposed Route 299 driveway and in-road bike lane on Route 299 in order to decide for yourselves if you think Empire State Trail users of all ages would be safe traversing them. The Town should not support an unsafe plan.

Today, New Paltz is renowned for the Village's portion of Main Street, an area characterized by walkability, density, and efficient building. This was the model that you had in mind when you rezoned the Town's Gateway and created the Main Street Mixed Use District. By contrast, the plan before you harkens back to an auto-centric model of suburban sprawl, exactly what you and the many volunteers and residents who contributed to the rezoning process were justifiably trying to avoid.

Few other votes you will make as board members will have the kind of permanent, material impact on the town. You have a chance to reject a design that might have been welcomed in the 1960s or 1970s but which is entirely inappropriate today. In a time of climate emergency, this project—in its current form—would be a mistake as soon as it was built. A vote to deny this petition would be in the public interest and would leave open an opportunity for Trans-Hudson to return with an improved proposal."

Joseph Londa asked about the carrying capacity.

A motion was made by Councilwoman Seyfert-Lillis to keep the public hearing open. Seconded by Councilman Brownstein. There was a discussion but no vote.

Highway Superintendent Chris Marx spoke in support of the petition because the extension would be a big upgrade the water district.

The public hearing will be left open.
