

# Town Board Meeting December 21, 2023, 7:00 p.m. 59 N. Putt Corners & Via Videoconference

**Present**: Supervisor Neil Bettez, Councilwoman Alex Baer, Councilwoman Julie Seyfert.

At 7:01 p.m. a motion was made by Supervisor Bettez to open the Town Board Meeting with the pledge. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

**Agenda:** A motion was made by Supervisor Bettez to adopt the agenda. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### **Public Comment:**

Kitty Brown thanked the Town Board, especially Councilwoman Alex Baer for another year of service. Looks forward to joining the Board and hopes 1/4/24 agenda includes interviews for Town Board position.

A motion was made by Supervisor Bettez to accept and approve the resignation of New Paltz Dispatcher, Emily Aldrich, effective December 31, 2023. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

# **Appointment of Det. Sgt.:**

A motion was made by Supervisor Bettez to appoint Calvin Halstead to Detective Sergeant effective January 1, 2024, at the rate outlined in the Collective Bargaining Agreement. Seconded by Councilwoman Seyfert, all aye votes cast, motion carried.

# **Dispatcher resignation:**

A motion was made by Supervisor Bettez to accept and approve Kaitlyn Reilly's letter of resignation as full-time dispatcher effective December 30, 2023, and approval to remain as part-time dispatcher effective January 1, 2024. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### Sewer bill reduction:

A motion was made by Supervisor Bettez to approve the reduction of the sewer portion of the October 2023 bill by \$1,936.56 due to a running toilet at 11 Cherry Hill and hold penalties while it's paid off. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

### **Grant Proposal:**

A motion was made by Supervisor Bettez to approve the Renewal Proposal for Grant Research Portal and Project Support Services with Millenium Strategies LLC. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

# **Grant application:**

A motion was made by Supervisor Bettez for the Town of New Paltz to commit to the 2023 TAP-CMAQ-CRP Program grant application local match requirements and funding match as required by this New York Department of Transportation administered program. Seconded by Councilwoman Baer, all ave votes cast, motion carried.

# **Vehicle auction:**

A motion was made by Supervisor Bettez to allow the Highway Department to resubmit a 2003 Ford Explorer for auction since the winning bidder backed out and the next highest bidder is not interested; and to allow the Highway Department to scrap the 2003 Ford Explorer for market value price if the next bid fails. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### **Warrant**

A motion was made by Supervisor Bettez to approve the December Warrant in the amount of \$1,441,322.81. Seconded by Councilwoman Baer, all aye votes cast, motion carried.
