A. MAIN ROOM (26' X 48') HOURLY RATES:

Private Party/Event: Resident* (R): \$50.00

Private Party/Event: Non-Resident* (NR): \$75.00

Businesses:

- Charging a fee: \$70.00 R; \$90.00 NR * Not Charging: \$50 R; \$70 NR
- Not charging a fee, open to the public and providing a public service: \$25.00 R; \$45.00 NR
- Not-for-Profit charging a fee: \$50.00 R; \$60.00 NR
- Not-for-Profit not charging a fee: \$30.00 R; \$40.00 NR

New Paltz Not-For-Profit Groups & Agencies: Up to two hours of use, \$5 per hour, \$25 yearly, non-consecutive weeks. Consecutive weeks: \$10/hr; \$50 yearly; \$15 per additional hour over two.

Other Not-For-Profit Groups & Agencies: Not charging: \$20/hr; charging: \$30/hr

Recreation Programs: Charging, with fee/program approval \$15.00/hr, NP Not for Profits, \$10.00/hr

Fee to instructors receiving donations: \$10.00/hr

Recreation programs paid to instructor: \$40.00/hr

Above rates apply if lower than below rates, no charge to individuals and groups not charging for programs, events and services and sponsored by N.P. Recreation. N/A to businesses. Non-Food Beverage use for rates B, C, D, rates C & D, N/A to businesses.

B. CONFERENCE ROOM (Accommodates 8): \$15/hr R; \$25/hr NR

C. MAIN ROOM, ONE THIRD USAGE: 16'x26', 416 sq ft: \$20/hr R, \$30/hr NR

D. MAIN ROOM, TWO THIRDS USAGE: 26'x32', 832 sq ft: \$25/hr R, \$35/hr NR. Partitioned main room N/A with food/beverage use unless approved by New Paltz Recreation.

All programming /events are scheduled through Parks & Recreation, (845) 255-2512, or recreation@townofnewpaltz.org. Rentals require facility usage and rules and regulations forms. A \$150.00 deposit is required for Event/Party reservations, returnable or shredded after rented space is inspected by staff and deemed reasonably clean and damage-free. Rental checks are to be received one week prior to venue use; checks/money orders are to be made out to Town of New Paltz. Residents receive a 10% discount on all programs.

Village/Town Residency is established by where property tax is paid by an individual or their landlord. Non-Resident fees may apply to programs and/or events that are offered free of charge by the Town of New Paltz to New Paltz residents.
