A motion was made by Supervisor Bettez to allow Comptroller Gallucci to provide the necessary funds as authorized in a prepay to extend the contract for the purchase of land associated with WD #5, up to \$200,000. Seconded by Councilman Torres, all aye votes cast, motion carried.

Resolution- Approve and Endorse Grant Application:

A motion was made by Supervisor Bettez to approve the following resolution and authorize the Supervisor to execute documents when available:

WHEREAS, the Town of New Paltz is applying to the Hudson River Valley Greenway for a grant under the Greenway Communities Grant Program for a project entitled The 299 Gateway Planning and Zoning Project to be located in the Town of New Paltz.

WHEREAS, the grant application requires the applicant municipality to obtain the approval/endorsement of the governing body of the municipality or municipalities in which the project will be located; NOW, THEREFORE, be it resolved that the governing board of the Town of New Paltz hereby does approve and endorse the application for a grant under the Greenway Communities Grant Program, for a project known as The 299 Gateway Planning and Zoning Project and located within this community. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

Letter of Support-RUPCO:

A motion was made by Supervisor Bettez to send a letter of support for RUPCO, Inc. in their application for funding on behalf of Ulster County through the NYS Office of Community Renewal (OCR) through the Community Development Block Grant Program (CDBG) to support owner occupied housing rehabilitation in Ulster County. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Moriello Water Loop Project Re-Bidi

A motion was made by Supervisor Better to authorize the Town Clerk to put the project out to bid. Seconded by Council woman Seyfert-Lillis, all aye votes cast, motion carried.

Resolution-CoolBot:

A motion was made by Councilman Torres to adopt the resolution to designate the Town Board Lead Agency, declaring this action as a Type II action, for the proposed agreement for the installation of a refrigeration unit at the New Paltz Re-Use Center. Seconded by Councilman Irwin, all ave votes cast, motion carried.

Resolution-CoolBot:

A motion was made by Supervisor Bettez to adopt the resolution authorizing the Supervisor to sign the agreement and other documents between the Town and the Food Insecurity Collaborative led by Family of New Paltz, Inc., for the installation, use and maintenance of a refrigeration unit at the New Paltz Re-Use Center. Seconded by Councilman Torres, all aye votes cast, motion carried.

Local Law #5/2016-"Town Supervisor Term Increase":

A motion was made by Councilman Torres to adopt a resolution for the adoption of the law entitled, "A local law to increase the term of Office of the Elected Town Supervisor from Two (2) Years to Four (4) Years" as Local Law #5 of 2016. (LLs had to be renumbered due to ballot referendums and filing requirements) Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

Public Hearing-Tax Cap Local Law:

A motion was made by Councilwoman Seyfert-Lillis to set the date for the public hearing on the proposed Tax Cap local law for October 27th at 7:15 p.m. Seconded by Councilman Irwin, all aye votes cast, motion carried. A motion was made by Supervisor Bettez to amend the prior motion and that the public hearing be set for October 20th at 7:15 p.m. Seconded by Councilman Torres, all aye votes cast, motion carried.
