Walden's proposed scope of work is outlined below in accordance with the Town's request.			
Task A. Assist with Response to the NY DEC			
1. Prepare response to 4/13/2023 DEC letter from D. Upright (DEC Correspondence) on behalf of the Town of New Paltz regarding the Ohioville Wastewater Treatment Plant (Response). The Response will include the following:			
Walden will reach out/communicate with DEC/Upright on behalf of the Town; summarize discussion			
Walden will prepare a written response to DEC/Upright as requested in the DEC Correspondence.			
2. Walden will submit electronically on or by May 31, 2023 or as otherwise authorized by the DEC/Upright			
3. Walden will prepare initial summary of new SPDES permit for Ohioville and plan for regulatory compliance until interconnection (see Task B)			
Task B. Assist with Intergovernmental Agreement with the Village			
1. Continue Town efforts toward a long-term agreement for the treatment of sewage from Ohioville by the Village of New Paltz			
Walden will reach out/communicate with the Village on behalf of the Town; summarize discussions			
Walden will prepare initial drafts of IGA for the treatment of sewage from the Town to the Village			
Walden will work with Town department(s) to uncover and visually verify the location of buried sewer conduits at Thruway/Exit 18			
Task C. Assist with County ARPA and 2023 CFA Applications for Infrastructure Funding			
1. Walden will assist the Town with engineering and other related aspects of securing County ARPA funding (\$500K Award)			
2. Continue Town efforts toward construction funding assistance for the treatment of sewage from Ohioville by the Village of New Paltz			
Walden will update, enhance recent CFA applications (2022 and 2021) regarding construction funding and other assistance			
3. Submit minimum of two CFA for Ohioville (from item 2 of Task C) by July 2023 deadline
