AUTHORIZING THE TOWN OF NEW PALTZ TO IMPLEMENT, AND FUND THE FIRST INSTANCE 100% OF THE FEDERAL-AID {AND STATE "MARCHISELLI" PROGRAM-AID} ELIGIBLE COSTS , OF A TRANSPORTATION FEDERAL-AID PROJECT, AND APPROPRIATING FUNDS

At a meeting of the Town Board of the Town of New Paltz, Ulster County, New York, held at the Town Courthouse, 59 N. Putt Corners Rd., in said Town on the 7th day of September, 2023, at 7:00 o'clock P.M., prevailing time.

The following resolution was offered by _____ who moved its adoption, seconded by _____, to wit:

WHEREAS, a Project for the Henry Dubois Drive (HWD) Bike and Pedestrian Lanes in the Town of New Paltz, PIN 8762.48 (the "Project") is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the Town of New Paltz desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of right-of-way acquisition, construction, and construction inspection work.

NOW THEREFORE, BE IT RESOLVED, that the New Paltz Town Board hereby approves the above-subject project; and it is hereby further

RESOLVED, that the New Paltz Town Board hereby authorizes the Town of New Paltz to pay in the first instance 100% of the federal and non-federal share of the cost of right-of-way acquisition, construction, and construction inspection work for the Project or portions thereof; and it is further

RESOLVED, that the sum of **\$2,636,000 (\$3,196,000 minus the previous \$560,000)** is hereby appropriated from _____ [or, appropriated pursuant to _____] and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the New Paltz Town Board shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Supervisor thereof, and it is further

RESOLVED, that the Supervisor of the Town of New Paltz be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or applicable Marchiselli Aid on behalf of the Town of New Paltz with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that in addition to the Supervisor, the following municipal titles: Town Engineer, Town Comptroller, Jean Gallucci are also hereby authorized to execute any necessary Agreements or certifications on behalf of the Municipality/Sponsor, with NYSDOT in connection with the advancement or approval of the project identified in the State/Local Agreement;

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and it is further

RESOLVED, this Resolution shall take effect immediately.
