**WHEREAS**, a local law for the purpose of providing a partial tax exemption upon certain real property based upon the owner’s membership in the New Paltz Fire Department or New Paltz Rescue Squad volunteer organizations, as permitted by Section 466-a of New York’s Real Property Tax Law proposed as Local Law No. \_\_\_\_ for the year 2023 was introduced at a meeting of the Town Board of the Town of New Paltz on the \_\_\_\_ day of \_\_\_\_\_, 2023, with a copy thereof having been duly given to all council members; and

WHEREAS, the intent and purpose of the local law is to provide a partial exemption from taxation imposed by the Town of New Paltz upon certain real property situated within the Town of New Paltz owned by persons who voluntarily serve as members of the New Paltz Fire Department or the New Paltz Rescue Squad under the

parameters set forth herein, pursuant to the authority vested in the Town by § 466-a of the Real Property Tax Law of the State of New York; and
