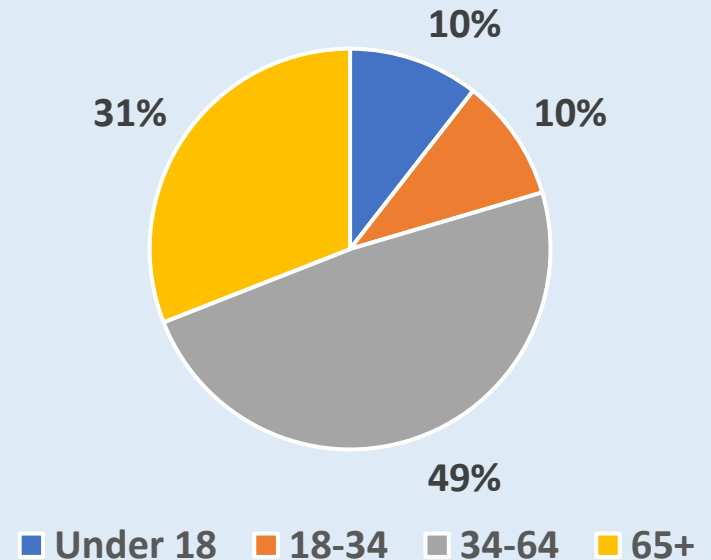
## Q1 Residence

- 100% in the Postcard Group were Residents
- 92% in Non-Postcard Group were Residents.

## Q2 Age

- Postcard Group Trended to be Older (No respondents under 18 )
- 14% of Non-postcard Group were Under 18
- Overall, 79% of Respondents were in the Upper Two Age categories: 34 and Older.

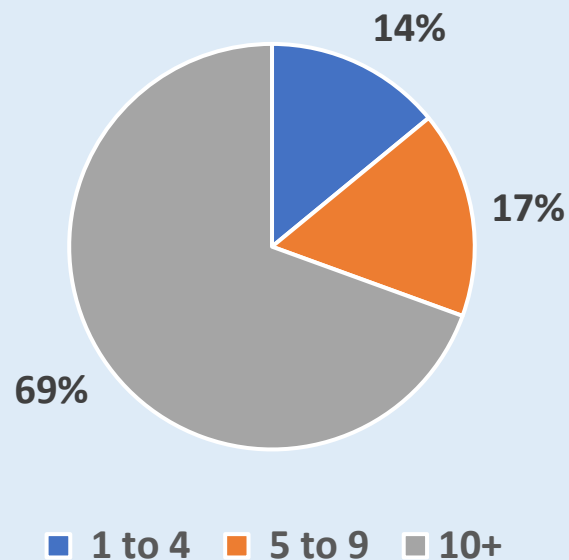
## Combined Age Distribution



## Q3 Years in New Paltz

Combined Years Lived in New Paltz

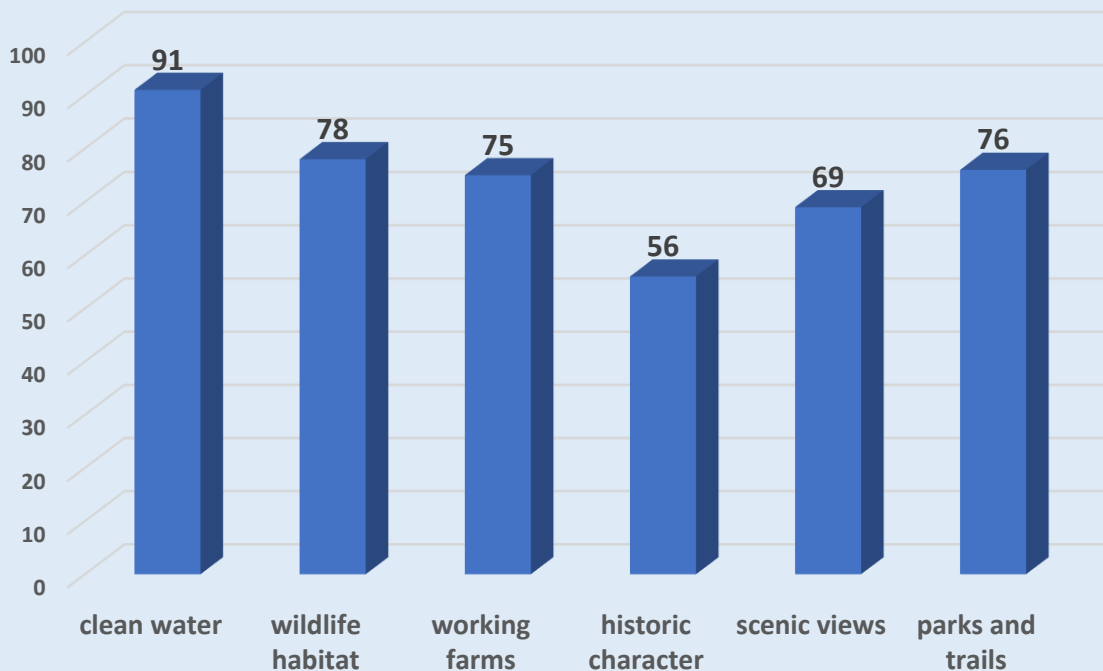

Resources Considered Very Important (%)

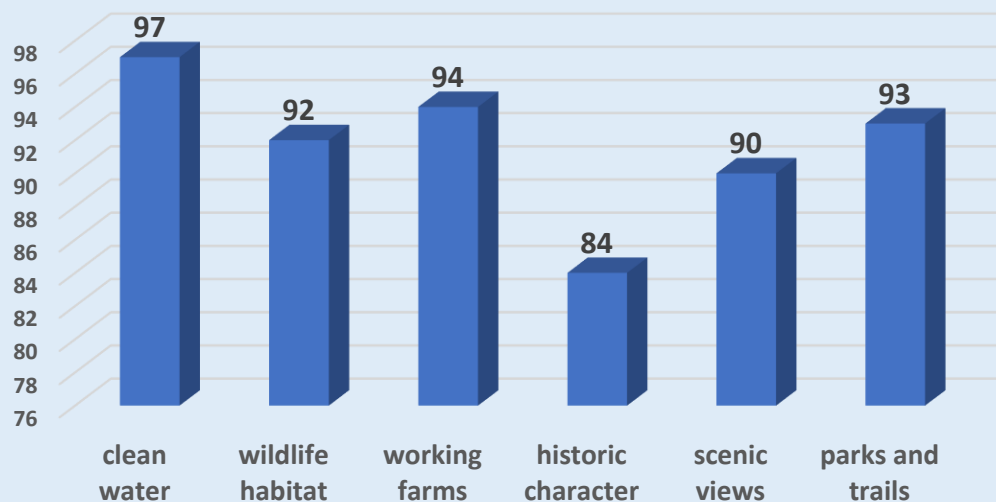

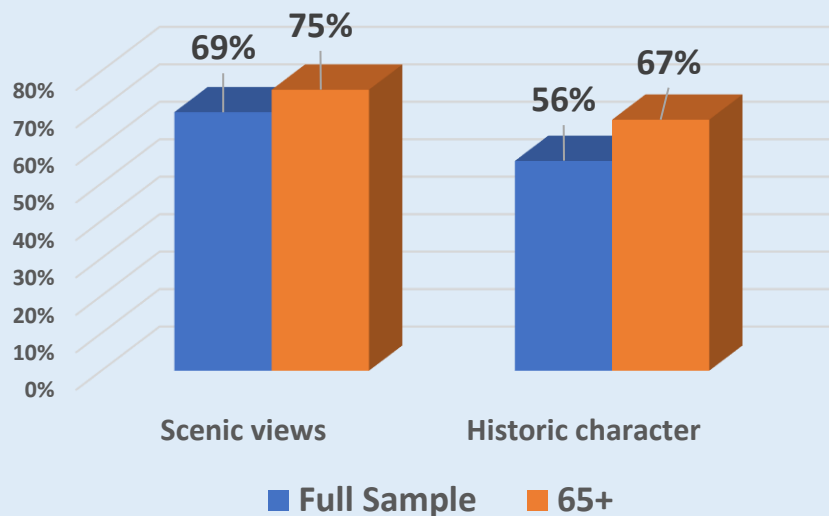
## Q4 Importance of Conserving Resources: Filtered by Age 65+

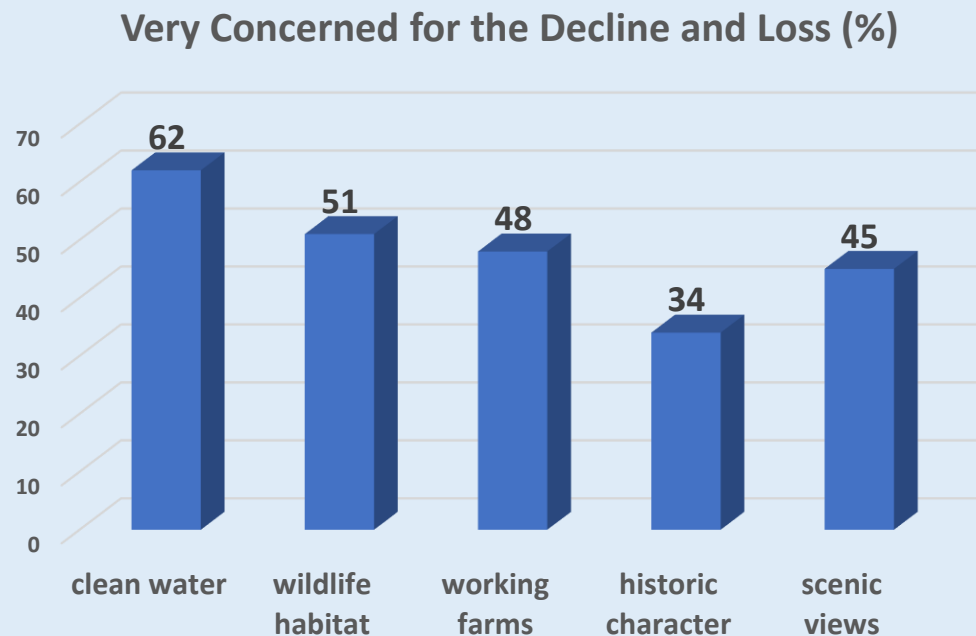

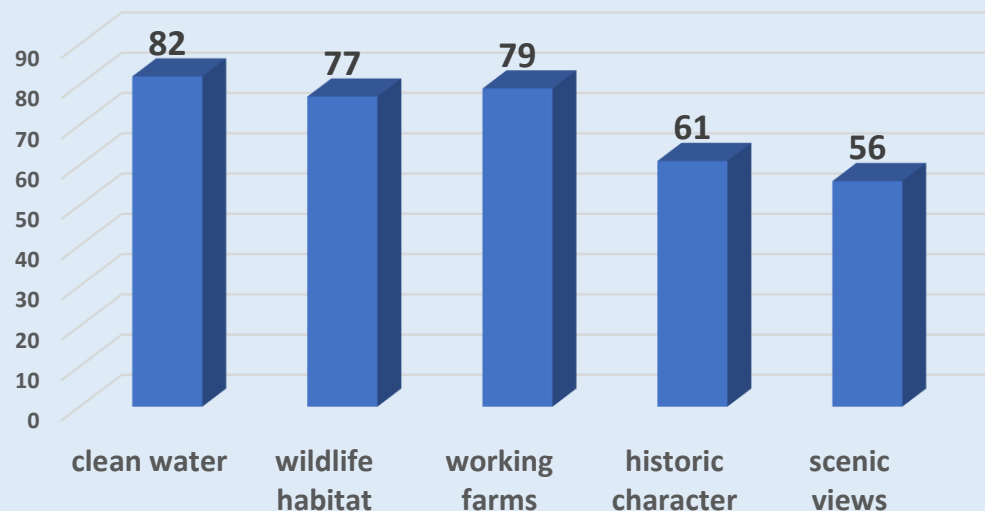

Concern for the Decline and Loss Combined (%)



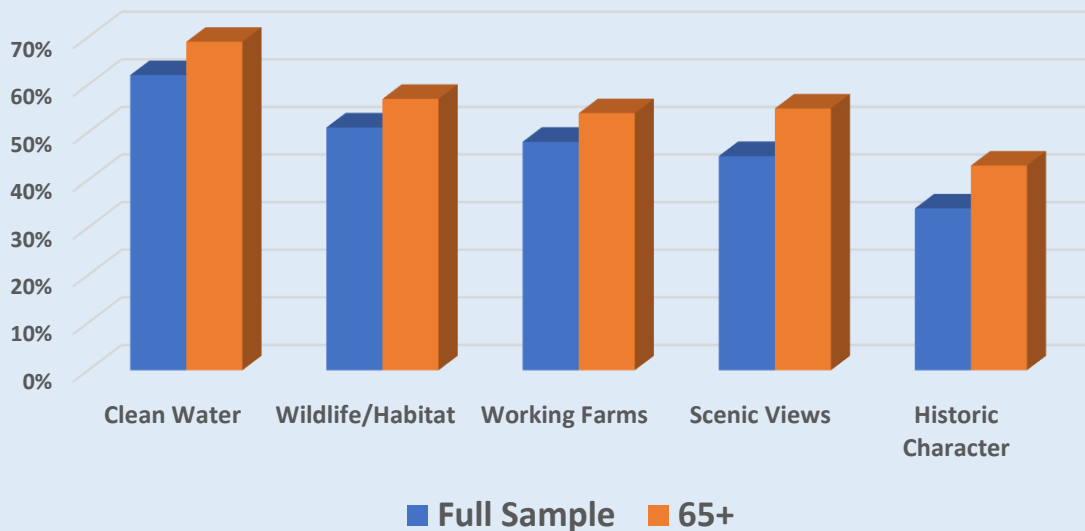

- The largest group was the category **“not certain/no opinion” 43%.**
- Remaining split between yes and no, 28% and 29% respectively.

Likely a number of respondents don't know what the Town is doing.

Importantly, it's possible that some were thinking about the Town residents, rather than the Town government, as it wasn't specified.

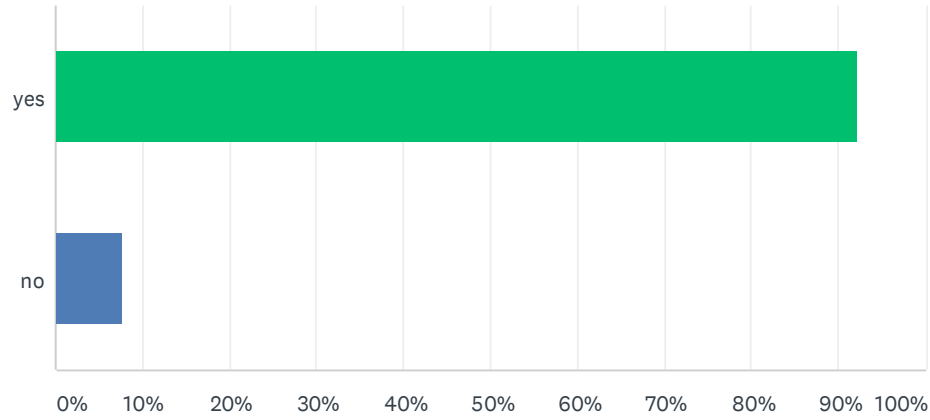

## Q1 Are you a New Paltz resident?

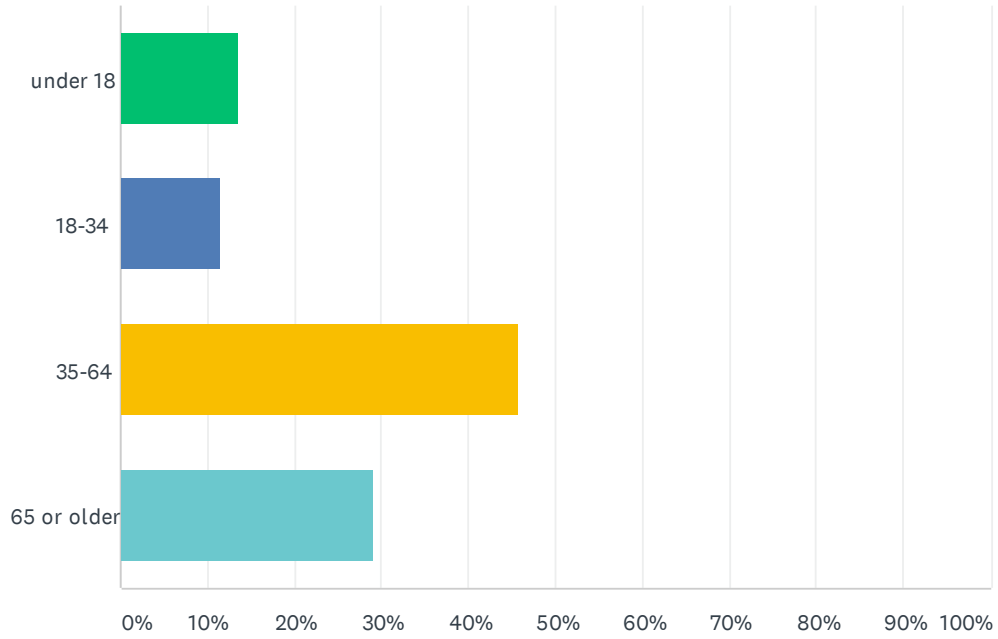

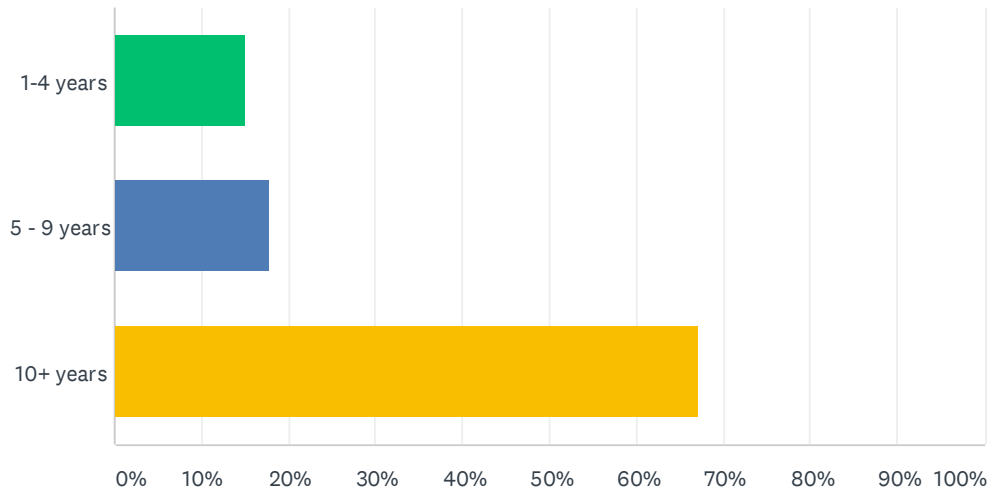

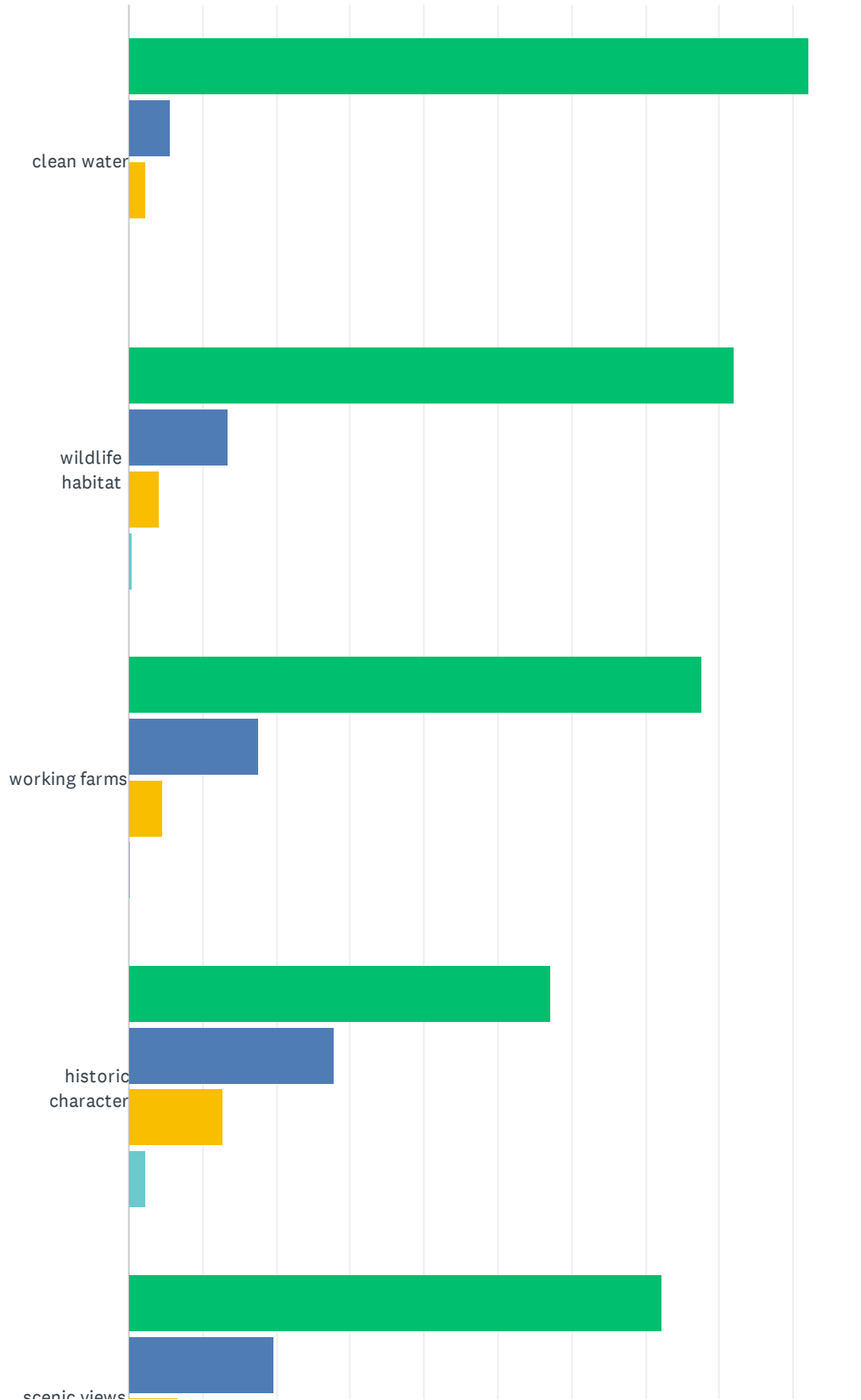

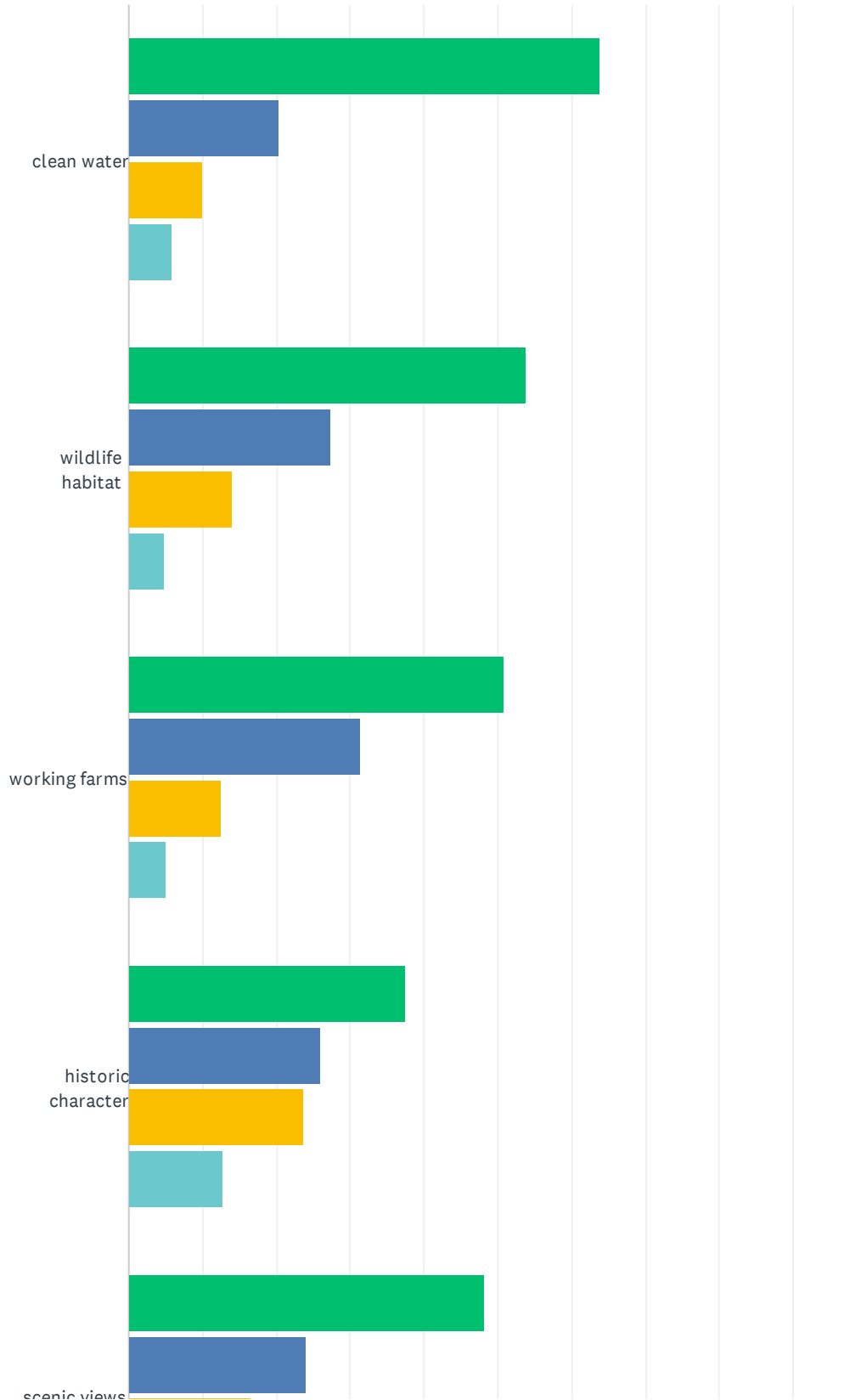

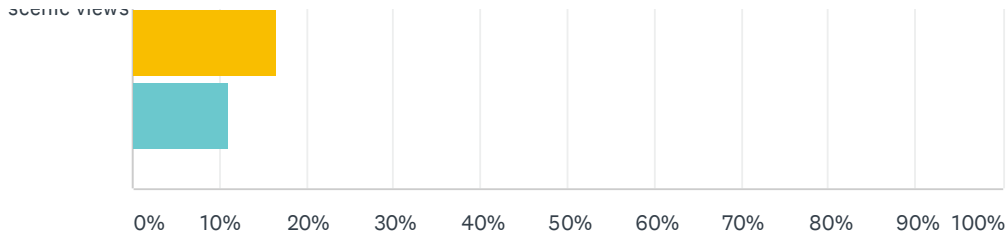

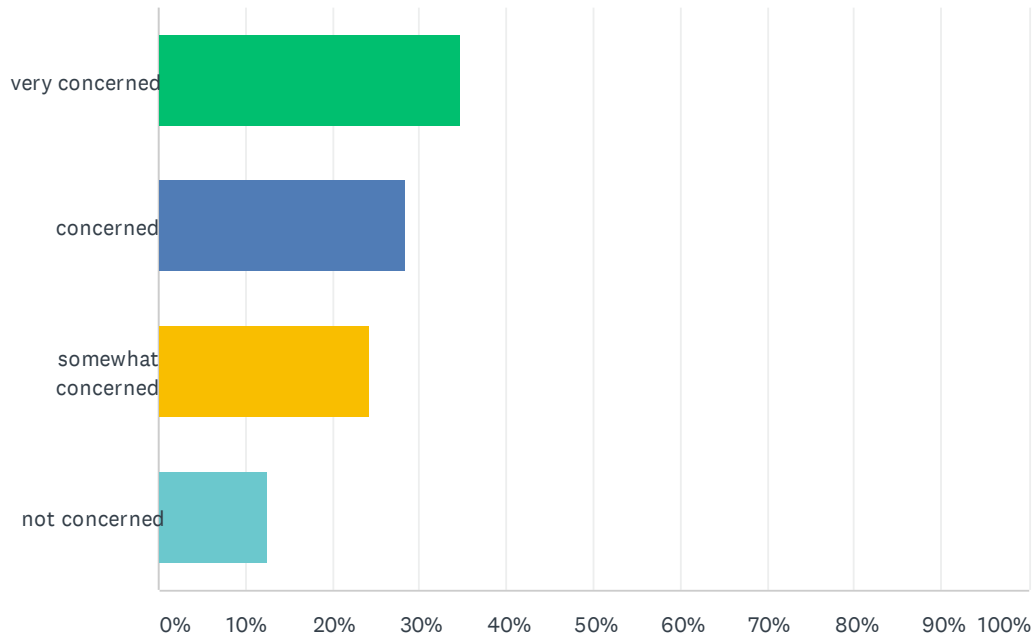

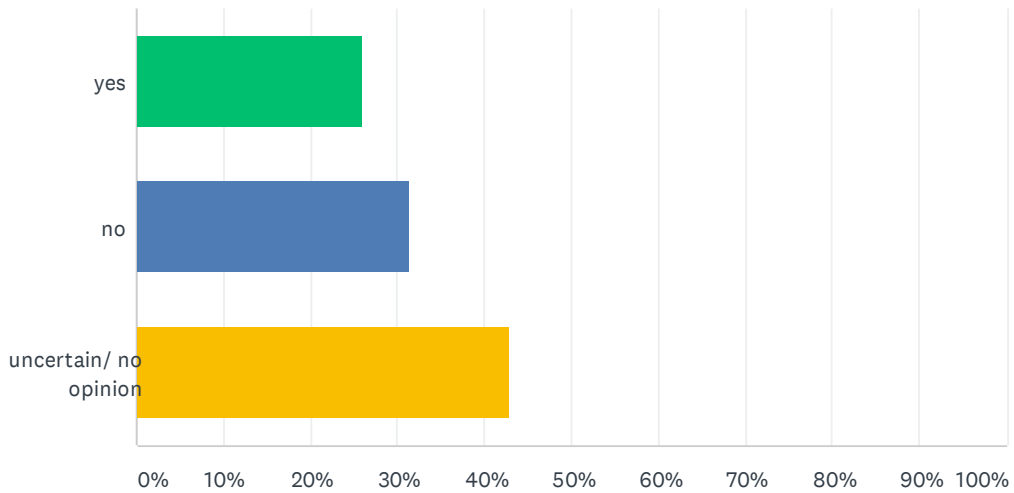

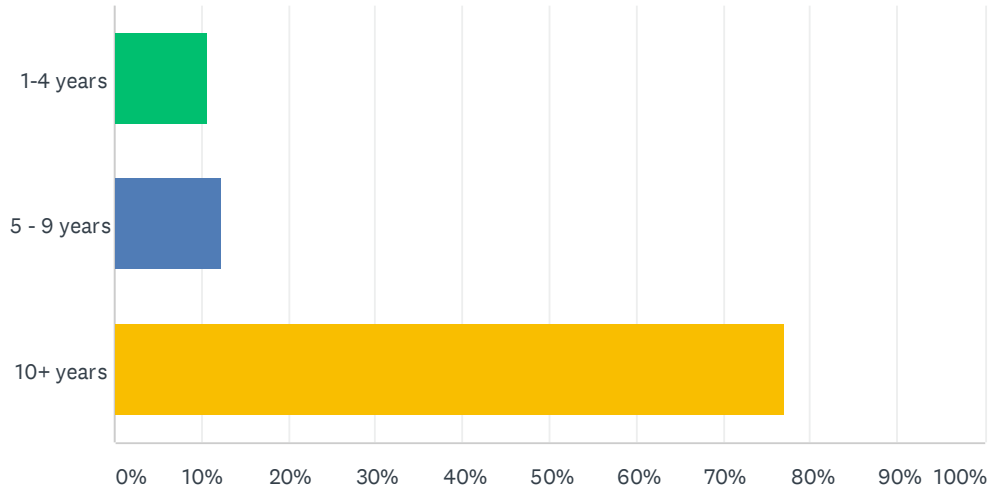

### Q3 How long have you lived in New Paltz?

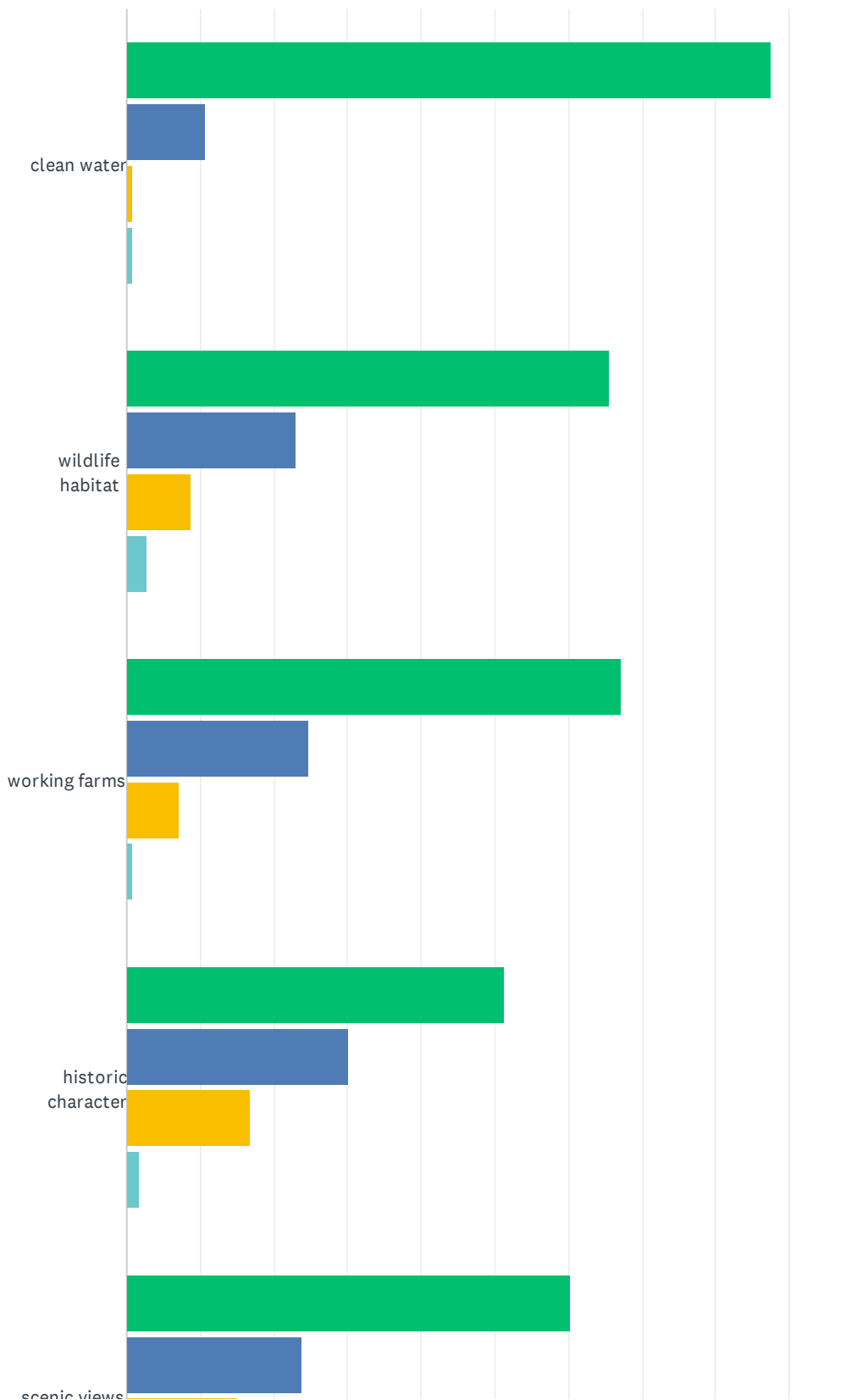

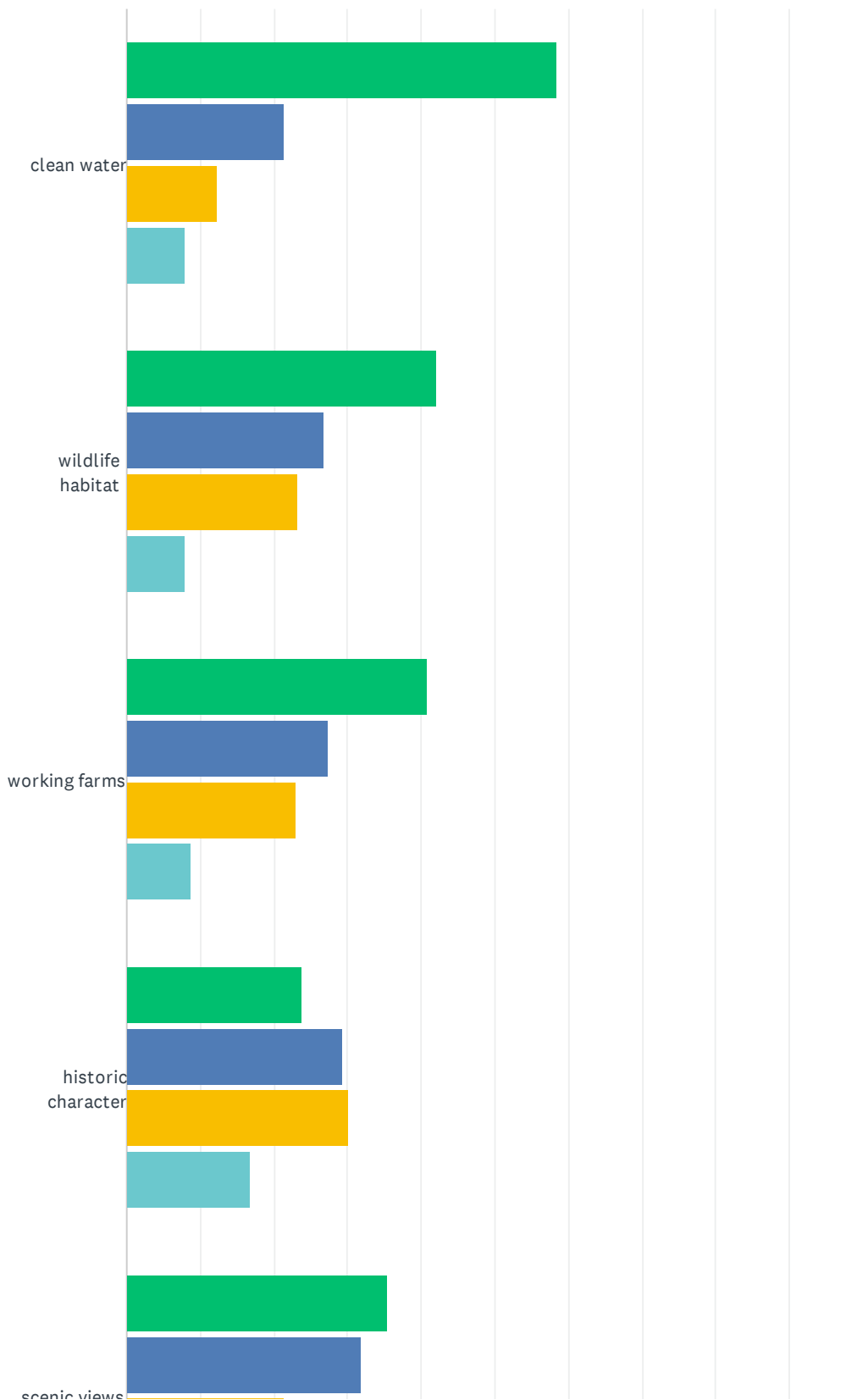

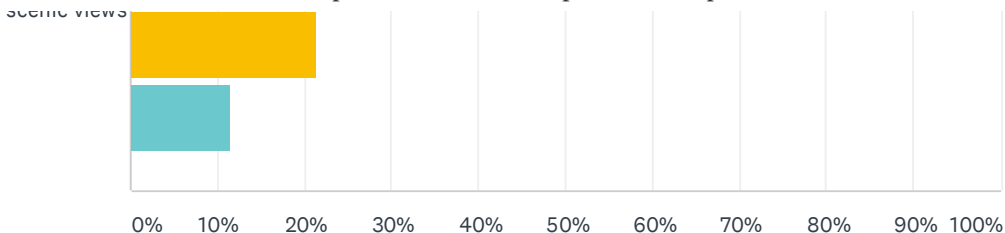

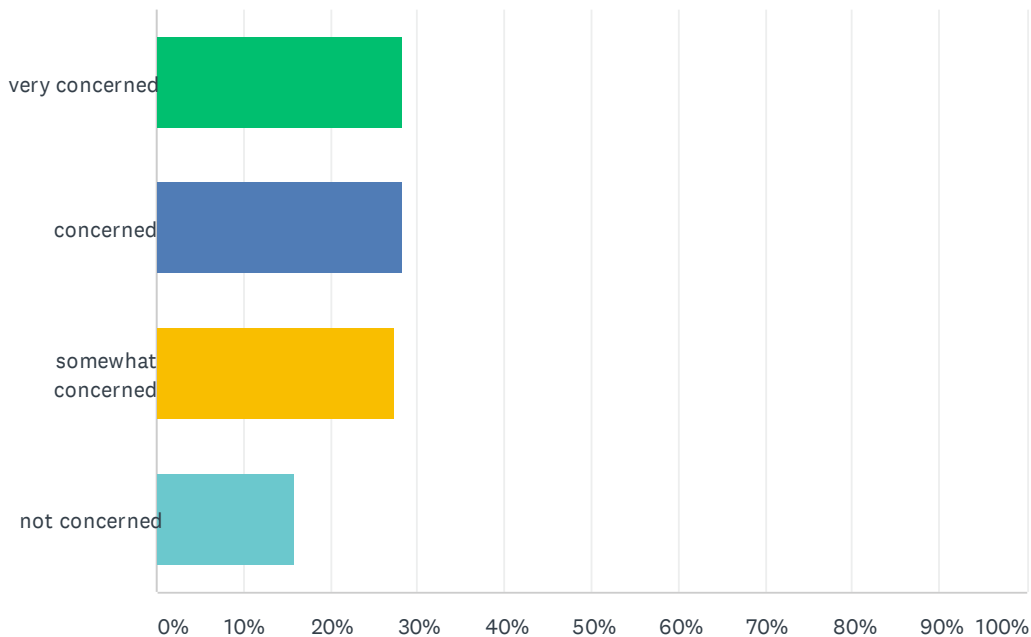

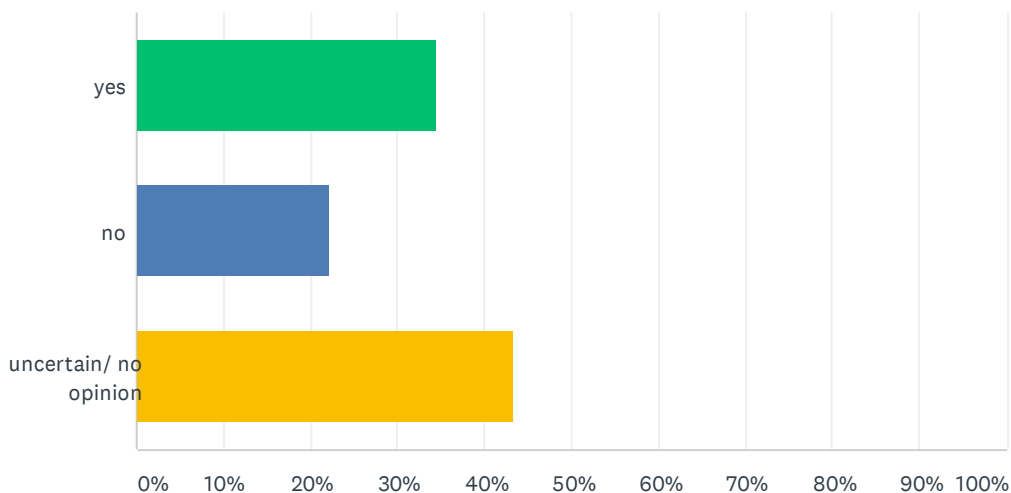
