RESOLVED that among other things, the bids shall contain a non-collusion certificate required by General Municipal Law, Section 103-d, and that the Town Board reserves the right in its discretion to waive technical non-compliance, or irregularities that are not material or substantial and to reject all bids and to re-bid the project; and it is further

RESOLVED that Supervisor of the Town of New Paltz is hereby authorized to execute and acknowledge on behalf of the Town such documents as are reasonable and necessary to give full force and effect to the intents and purposes of this resolution regarding the preparation of bid specifications and the advertising of bids.

ADVERTISEMENT FOR BIDS

Sealed bids for the furnishing of all labor and material necessary for the Town of New Paltz Phase III Backup Water Supply, Contract No. 2, Plains Road Well House Construction and Contract No. 3, Water Distribution Main Improvements, will be received by the Town of New Paltz, 52 Clearwater Road, New Paltz, New York 12561 until 11:00AM local time on Friday August 27th 2021 at which time and place they will be publicly opened and read aloud.

Bids will be received for the following Contracts:

Contract No. 2A – General Construction: Scope of work consists of construction of the Plains Road Well House, including the furnishing and installation of well pumps, sodium hypochlorite dosing systems, a clear well, distribution pumps and associated instrumentation, control and process piping and appurtenances.

Contract No. 2B – Mechanical Construction: Scope of work consists of mechanical improvements associated with the construction of Plains Road Well House.

Contract No. 2C – Electrical Construction: The work generally consists of the installation of all electrical systems within and adjacent to the new well house. The systems new site services including coordination with electrical and telephone utility providers, outdoor diesel generator, automatic transfer switch, motor control center with variable frequency drives, interior and exterior lighting, building grounding, underground electrical, electrical distribution conduit/wiring, control systems conduit/wiring/terminations, mechanical equipment connections, and other miscellaneous electrical systems as required for a complete and operational facility.

Contract No. 3 – General Construction: Installation of approximately 4,800 linear feet of 6-inch and approximately 8,600 linear feet of 8-inch ductile iron water main associated with the well site off of Plains Road and throughout Plains Road neighborhood. Scope of work consists of excavation and trench preparation for the new water main, installation of new water main piping, including water valves, new water services, new water meters, corporation and curb stops, new service piping, new hydrant assemblies, and restoration of existing surfaces including asphalt pavement, gravel drives, and grass. Water main construction includes work zone traffic control and erosion and sediment control.

Each bid must be accompanied by security in an amount not less than five percent (5%) of the amount of the bid in the form and subject to the conditions provided in the Information for Bidders. No Bidder may withdraw his bid within forty-five (45) days after the actual date of opening thereof.

This is an exempt capital improvement project, and Bidders shall not include in their bid sales and compensating use taxes on the cost of materials which are to be incorporated into the work and which are to be separately sold by the Contractor to the Town of New Paltz prior to incorporation into the work of the Contract.

The attention of Bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the Contract.
