**ASSUMPTION OF SEQRA LEAD AGENCY, TYPING ACTION AS A  
TYPE II ACTION UNDER SEQRA**

**WHEREAS**, the Town Board of the Town of New Paltz (Town) desires to enter into a Grant Agreement with the New York State Environmental Facilities Corporation regarding the Town’s Engineering Planning Grant Application Number 94026 for a Sanitary Sewer Inflow and Infiltration Study as part of the 2020 Consolidated Funding Application process;

**WHEREAS**, the Town Board of the Town of New Paltz desires to undertake the necessary review of such Sanitary Sewer Inflow and Infiltration Study under the State Environmental Quality Review Act (“SEQRA”); and

**WHEREAS**, Title 6 of the New York Code of Rules and Regulations (6 NYCRR) Section 617.5 under the State Environmental Quality Review Act (SEQR) provides that certain actions identified in subdivision (c) of that section are not subject to environmental review under the Environmental Conservation Law.

**NOW, THEREFORE, BE IT**

**RESOLVED** that the Town of New Paltz Town Board hereby determines that the proposed Sanitary Sewer Inflow and Infiltration Study is a Type II action in accordance with the listed 6 NYCRR Section 617.5(c) (1), (2), (24) or (27) and constitutes the

- (1) maintenance or repair involving no substantial changes in an existing structure or facility;
- (2) replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building, energy, or fire codes unless such action meets or exceeds any of the thresholds in section 617.4 of this Part;
- (24) information collection including basic data collection and research, water quality and pollution studies, traffic counts, engineering studies, surveys, subsurface investigations and soils studies that do not commit the agency to undertake, fund or approve any Type I or Unlisted action; or

(27) conducting concurrent environmental, engineering, economic, feasibility and other studies and preliminary planning and budgetary processes necessary to the formulation of a proposal for action, provided those activities do not commit the agency to commence, engage in or approve such action.

and is therefore not subject to further review under 6 NYCRR Part 617.
