WHEREAS, proposed Local Law No. _____, 2021 was introduced at a meeting of the Town Board of the Town of New Paltz, County of Ulster, State of New York, on the _____ day of _____, 2020, with a copy thereof having been duly given to all council members, the intent and purpose of which is to provide restrictions for the parking, stopping and standing of vehicles on all highways within that portion of the Town of New Paltz lying outside the geographical boundaries of the incorporated Village of New Paltz during emergencies and accumulations of snow and ice and to thereby promote and protect the safety, health and well-being of persons and property within the Town; and

WHEREAS, due notice of a public hearing to be held thereon on the _____ day of _____, 2021, was duly published in the "New Paltz Times," a newspaper printed
