New Paltz Police Reform & Reinvention Collaborative:

Esi Lewis and Randall Leverette indicated that next week they will be holding a virtual Town Hall meeting and in November they will be meeting with specific groups and stakeholders weekly. The NPPRRC will also be requesting a budget of \$2,400 for a researcher to help compile information and some editing.

Discussion- Sex Offender Housing:

Commissioner Bettez indicated that currently there are 4 Level 3 offenders under post release supervision residing at the Econo Lodge in New Paltz, which is currently the only location in Ulster County. Soon there will be another Level 3 and 1 Level 2 offender totaling 6 offenders in this location. The State pays for them to live there for 1 month while they are transitioning. The Town can pass a law limiting the number of offenders that can be in a single place. The Town of Lloyd currently has a law in place. The Board will look into a similar one for New Paltz, intime for the next meeting.
