b. Approval of renewal of Marshall & Sterling Insurance policy effective 11/30/2020

Resolution-New Chapter 92, "Hotels and Motels":

A motion was made by Supervisor Bettez to designate the Town Board Lead Agency and declare this a Type II Action under SEQRA. Seconded by Councilman Brownstein, all aye votes cast, motion carried.

A motion was made by Supervisor Bettez to schedule the public hearing for November 12th at 7 p.m. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

2021 Budget Discussion:

Supervisor Bettez indicated that since the last meeting, significant cuts were made by Town departments, especially Highway and Police. The new budget reflects a tax increase of 1.56%, which is the Tax Cap, down from 4.3% and does not include any layoffs. Spending was cut \$555,000 from last year. The hope is that revenues will increase for 2021. The public hearing on the Preliminary Budget has been scheduled for November 5th at 7 p.m.

Highway Budget Modification-Tabled from 10/15 meeting:

The Board feels there is a significant need to replace the dump body of the Highway's 2006 Sterling truck.

A motion was made by Councilman Brownstein to approve the transfer of \$22,000 from Snow Removal line DBB-522-5142-400 to the Machinery line DBB-522-5130-200 for the purchase of a dump body for the 2006 Sterling. Seconded by Supervisor Bettez, all aye votes cast, motion carried.

Youth Center Hire:

A motion was made by Supervisor Bettez to accept the resignation of Margaret Formisano. Seconded by Councilman Torres, all aye votes cast, motion carried.

Now there are no female counselors working at the Youth Center and Jim Tinger is requesting the Board hire Heaven Torres.

A motion was made by Councilman Torres to hire Heaven Torres at \$15/hr for 20/hrs/week. There seems to be confusion regarding Jim Tinger's request. There was no second to this motion. A motion was made by Councilwoman Baer to offer Heaven Torres the part-time position. Seconded by Councilman Brownstein, all aye votes cast, motion carried.

At 7:33 p.m. a motion was made by Supervisor Bettez to adjourn. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.
