**Present**: Commissioner Neil Bettez, Commissioner Alex Baer, Commissioner Dan Torres, Commissioner Julie Seyfert-Lillis, Commissioner David Brownstein, and Chief Robert Lucchesi.

At 6:31 pm a motion was made by Commissioner Bettez to open the Town Board as Police Commission meeting with the pledge. Seconded by Commissioner Torres, all aye votes cast, motion carried.

### Agenda:

A motion was made by Commissioner Bettez to approve the Police Commission agenda as written. Seconded by Commissioner Seyfert-Lillis, all aye votes cast, motion carried.

#### **Public Input:**

- -Harper Keen- Discussed the lack of progress of steering committee and proposed the following questions:
  - 1. Would like to know the status of the police reform and reinvention committee?
  - 2. Has the collaborative come up with a timeline?
  - 3. Where will minutes be posted?
  - 4. What is rationale behind hiring new police officers?
- -Tanya Marquette- Stated the reinvention/reimaging committee process has been very unwelcoming to the community and disliked member selection process. Committee members are unreachable and are providing no transparency to the community as to what they are doing or discussing.
- -Maggie Veve- Echoed what Tanya Marquette stated. Believes Town Board should serve as a model as to what the police should be doing and is disappointed about steering committee.
- -Edgar Rodriguez- Is shocked that there are no updates from anyone as to what is going on with regards to steering committee. Steering committee aren't doing what they should do with no transparency to the community.
