At 6:31 p.m. a motion was made by Commissioner Bettez to open the meeting with the pledge. Seconded by Commissioner Torres, all aye votes cast, motion carried.

Agenda: A motion was made by Commissioner Bettez to adopt the agenda as written. Seconded by Commissioner Torres, all aye votes cast, motion carried.

Public Input:

Mateo __, resident, had questions and concerns regarding anti-racism efforts and how the Town can build familiarity, trust and recognition with community members and police officers.

Monthly Report-July 2021:

- -Increase in Detective cases from last year.
- -An officer was assaulted at Moriello Pool, the subject was charged with a felony.
- -A subject involved in a fight spit blood and saliva into the face and mouth of an officer. The subject stated that he was HIV positive. He was charged with a felony.
- -The PD was able to identify and apprehend 2 of the 3 suspects and the firearm involved in an armed robbery.

Training Report:

Officers White, Vespe and Claud attended NPPD new hire in-service training.

Chief Lucchesi clarified from the last meeting, that the policy regarding body worn cameras is in alignment with what the committee recommended.

Review recommendation of the NPPRRC: Any time an officer stops a civilian, they must provide the person with a business card containing their name and badge number and a clear reason for the stop (no "do you know why I pulled you over?") allowed:

Chief Lucchesi indicated that the V&T Policy had already been amended to require the Officer to Offer and provide their business card.

Review recommendation of the NPPRRC: A discipline matrix be created for the NPPD within the next six months which includes penalties for unauthorized use of force and failure to utilize body cameras:

Chief Lucchesi agrees with the recommendation. He feels it is important to provide a certainty to the public and the officer. The plan is to provide a draft to the labor attorney and the NPPRRC then to the Commission for review.

Review and discussion newly issued policy 140.0 Personnel File FOIL Request. Policy issued to address the repeal of Article 50-a and the New York State Civil Rights Law and provides guidance on how requests are processed:

Chief Lucchesi indicated that a policy has been drafted by the Town's labor attorney, in consultation with the Union attorneys, which has been enacted and put into place. This policy makes the process more transparent.

Review and discussion of revised policy 50.2 Electronic Recording of Interviews and Interrogations. Policy revised with updated definitions, municipal training council updates and the interview of juveniles:

Chief Lucchesi indicated that some of the definitions were updated to be aligned with more modern media. The most important addition made was making sure all members know that any custodial interview and interrogation of the juvenile has to be recorded in its entirety.

Review and discuss the Citizens Police Academy Curriculum:

Chief Lucchesi indicated that it is scheduled to start September 8th but only 1 person has signed up. He needs a minimum of 10 people to sign up, otherwise it will have to be moved to the Spring. It is

an 8- week program, every Wednesday from 6-9 p.m. The curriculum includes various speakers from different agencies.

Review and Referral-Approval to hire:

A motion was made by Commissioner Bettez to refer the hiring of Meghan E. Miller as part-time dispatcher to the Town Board. Seconded by Commissioner Torres, all aye votes cast, motion carried.

At 7:50 p.m. a motion was made by Commissioner Bettez to adjourn the meeting. Seconded by Commissioner Torres, all aye votes cast, motion carried.
