1. Steve: **Crash Victim Rights and Safety Bill:**

Laura Pettit will introduce an Ulster County Crash Victims Rights and Safety resolution. Let's ask the town to pass the resolution too – Lou will forward email that town did pass already.

2. **Radar speed signs:**

Judy: Marbletown is only permitted to have the sign on certain hours of the day. They went through normal channels. Lou: the schedule is negotiable. NYS DOT thinks they are more effective if not on 24/7. Neil said portable/temporary signs require NYS DOT approval. True that letter of the law requires this, but in practice NYS DOT views this as police activity and don't enforce this requirement if temporarily placed. This could be a first approach. If we wish to do permanent, then Neil or Tim (depending on jurisdiction) should initiate a request to David Corrigan. The next step should be picking a location and then having a conversation with Tim/Neil.

3. Request for in-street crosswalk sign at Ridge Apartments / 32S. Request for more police enforcement of motorists failing to stop for pedestrians at crosswalks. Missing in-street crosswalk signs at Plattekill Ave / S. Oakwood Terrace as well as River to Ridge trailhead at Springtown Road. Dan contacted Facilities to see about in-street crosswalk sign by Ridge Apartments.

4. Judy: let's add flags to more crosswalks. Let's ask Bill Weinstein about what happened to the orange flags by Water Street Market. Let's draft a letter to the village making a request to the village. Let's ask Ryan Cronin art to make a "grab a flag" sign. Let's Ask for a flashing beacon at the Karma Road / Water Street Market crosswalk.

5. Request for more information from the county officials about speeding up the construction of **shoulders on Route 299** from Buttermilk Road to Route 44/55? Judy contacted Jim Bacon but hasn't heard back.
