

# Town Board Meeting August 18, 2022, 7:00 p.m. Via Videoconference

**Present**: Supervisor Neil Bettez, Councilwoman Alex Baer, Councilwoman Esi Lewis.

Absent: Councilman Dan Torres, Councilwoman Julie Seyfert-Lillis.

At 7:04 p.m. a motion was made by Supervisor Bettez to open the meeting with the pledge. Seconded by Councilwoman Lewis, all aye votes cast, motion carried.

#### Agenda:

A motion was made by Supervisor Bettez to adopt the agenda as written. Executive Session will be moved to later in the meeting. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### Review of 2<sup>nd</sup> revision to draft franchise agreement with Charter/Spectrum:

Anton Stewart, Chair of the Public Access Committee, discussed the changes being made to the franchise agreement in an effort to make it identical to the agreement between Charter/Spectrum and the Village of New Paltz. The Town Board will review the agreement and send any changes or revisions to Mr. Stewart before it is submitted to Charter/Spectrum.

At 7:13 p.m. Councilwoman Seyfert-Lillis arrived.

#### Resolution-Speed Limit Reduction on Elliot's Lane:

A motion was made by Supervisor Bettez to adopt the following resolution. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

Requesting the Ulster County Public Works Department establish a 30-mph speed limit on Elliot's Lane, a road in the Town of New Paltz

**WHEREAS,** the New York State Department of Transportation (NYSDOT) has the authority to establish speed limits on state highways, county, and town roads, and

WHEREAS, Elliot's Lane is a popular route for bicyclists, walkers, runners and other non-motorized users, and

**WHEREAS**, excessive speed in the area poses a danger to these users, and

WHEREAS, there is no current posted speed on Elliot's Lane, defaulting to a 55 mph speed limit,

**NOW THEREFORE BE IT RESOLVED,** that the Town Clerk is authorized to transmit this resolution to the County Commissioner of Public Works of the County of Ulster, asking the Department of Transportation to establish a maximum speed of 30 mph on Elliot's Lane, a Town road pursuant to Section 1622.1 of the Vehicle and Traffic Law, and 2) complete a TE9(a) form with the NYSDOT.

# Resolution-Speed Reduction on Horsenden Road:

A motion was made by Supervisor Bettez to adopt the following resolution. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

Requesting the Ulster County Public Works Department establish a 35-mph speed limit on Horsenden Road, a road in the Town of New Paltz

**WHEREAS,** the New York State Department of Transportation (NYSDOT) has the authority to establish speed limits on state highways, county, and town roads, and

**WHEREAS,** Horsenden Road is owned by Ulster County from its intersection with State Route 32 east to its intersection with N. Putt Corners Rd., and

**WHEREAS**, Horsenden Road is owned by the Town of New Paltz from its intersection with N. Putt Corners Rd. east to its intersection with N. Ohioville Rd., and

**WHEREAS**, the speed limit set by Ulster County for the County portion of Horsenden Road is 35 mph, and **WHEREAS**, the Town wishes to bring the Town-owned portion of Horsenden Road into alignment with the County speed limit

**NOW THEREFORE BE IT RESOLVED,** that the Town Clerk is authorized to transmit this resolution to the County Commissioner of Public Works of the County of Ulster, asking the Department of Transportation to establish a maximum speed of 35 mph on Horsenden Road, a Town road pursuant to Section 1622.1 of the Vehicle and Traffic Law, and 2) complete a TE9(a) form with the NYSDOT.

# <u>Authorization to sign joint permit applications for water supply project at Mountain Rest Rd.</u> and Moriello Park:

A motion was made by Supervisor Bettez to authorize the Supervisor to sign the joint permit applications if the Village provides written confirmation that there is dedicated storage space for the Town in the new shed being constructed on Mountain Rest; and to either move the path at Moriello or have a mural painted on a structure surrounding the well. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

# **Authorization to sell surplus equipment:**

A motion was made by Supervisor Bettez to authorize the sale of surplus equipment as follows: 1996 International 4800 Truck, 5<sup>th</sup> Wheel Truck and Arm mower attachment, with the funds from auctioned equipment to be placed into the Highway Reserve Fund; as long as the equipment is no longer needed. Seconded by Councilwoman Baer, all aye vote cast, motion carried.

# **Authorization to install split unit:**

A motion was made by Supervisor Bettez to authorize the installation of a split unit in the server room at the Police Department under emergency status in an amount up to \$25,000. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

# **Authorization to hire:**

A motion was made by Supervisor Bettez to hire Chuck Bordino as a part-time Recreation Director not to exceed 29 hours per week, for the period of August 30, 2022 through December 30, 2022 at the rate of \$20.11 per hour. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

#### **Authorization to hire:**

A motion was made by Supervisor Bettez to hire Marie Girard and Sharon Roth as temporary part-time Recreation Aides not to exceed 6 hours per week each, at the rate of \$16.00 per hour for the period of August 30, 2022 through December 30, 2022. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### **Authorization to hire:**

A motion was made by Supervisor Bettez to hire Max Cottet as a per diem Municipal Worker I for Recycling/ReUse at the rate of \$20.80 per hour. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

#### **Authorization to advertise:**

A motion was made by Supervisor Bettez to authorize advertising for a Recording Secretary to serve the Police Commission, Environmental Conservation Board and Community Preservation Fund Advisory Board on a contract basis at the rate of \$17-20/per hour. Seconded by Councilwoman Lewis, all aye votes cast, motion carried.

#### **Authorization to sign Agreement:**

A motion was made by Supervisor Bettez to authorize the Supervisor to sign Legal Fee Agreement with Joule Assets Inc. for legal action against Columbia Utilities Power, LLC and Columbia Utilities, LLC in Ulster Supreme Court Index EF2022-1113. Seconded by Councilwoman Lewis, all aye votes cast, motion carried.

# **Authorization to pay stipend:**

A motion was made by Supervisor Bettez to renegotiate the revised side letter from UPSEU dated 9/21/21 for 2022 regarding the stipend of \$2,250.00 for Stasha Dietz. Seconded by Councilwoman Baer, all aye votes cast, motion carried.
