

# Town Board Meeting February 17, 2022, 7:00 p.m. Via Videoconference

**Present**: Supervisor Neil Bettez, Councilwoman Alex Baer, Councilman Dan Torres, Councilwoman Esi Lewis, Councilwoman Julie Seyfert-Lillis.

At 7:31 p.m. a motion was made by Supervisor Bettez to open the meeting with the pledge. Seconded by Councilman Torres, all aye votes cast, motion carried.

**Agenda**: + #9 Authorization to hire for Building Department and Planning/Zoning. A motion was made by Supervisor Bettez to adopt the agenda as amended. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

### **Public Input:**

- -Edgar Rodriguez spoke about the Defensive Action report included in the Chief's January 2022 Monthly Report.
- -Maggie Veve was pleased to have guest speakers present information on NYS Police Academies.

### **Interviews for Police Commission:**

Johnny Coxum, Karrie Rahaman-Bunce, David Brownstein and Cindy Sanchez presented their background information and spoke about why they would like to be on the new Police Commission.

### **Discussion:**

Supervisor Bettez announced that Town Hall will be opening back up to the public, but the mask mandates will remain in place. The Town Board will discuss possibly returning to a hybrid meeting format at the next meeting.

A motion was made by Supervisor Bettez to spend up to \$1,200 to purchase A/V equipment for the Courthouse. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

A motion was made by Supervisor Bettez to approve the use of \$6,500.00 earmarked in the 2022 budget for new in-car computer systems as well as another \$2,500.00 from the computer reserve

fund to upgrade the existing in-car computer systems to operate the county records management system in patrol vehicles. Seconded by Councilman Torres, all aye votes cast, motion carried.

#### Warrant:

A motion was made by Supervisor Bettez to approve the February Warrant in the amount of \$2,342,507.51. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

#### **Executive Session:**

At 8:30 p.m. a motion was made by Supervisor Bettez to go into executive session to discuss personnel with Chris Marx. Seconded by Councilman Torres, all aye votes cast, motion carried. At 9:17 p.m. a motion was made by Supervisor Bettez to come out of executive session and authorize the Supervisor to sign the stipulation agreement with Theresa Hart. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

# Approval to hire for Building Department & Planning/Zoning:

A motion was made by Supervisor Bettez to approve the hiring of Brianna Tetro for the position of Planning & Zoning Board Secretary and Building Department Clerk effective March 7, 2022, at a rate of \$18.00/hr. Seconded by Councilwoman Baer, all aye votes cast, motion carried.
