

Town Board Meeting October 20, 2022, 7:00 p.m. 59 N. Putt Corners Via Videoconference

<u>Present</u>: Supervisor Neil Bettez, Councilman Dan Torres, Councilwoman Alex Baer <u>Absent</u>: Councilwoman Esi Lewis, Councilwoman Julie Seyfert-Lillis.

At 7:01 p.m. a motion was made by Supervisor Bettez to open the meeting with the pledge. Seconded by Councilman Torres, all aye votes cast, motion carried.

Agenda:

A motion was made by Supervisor Bettez to adopt the agenda as written. Seconded by Councilman Torres, all aye votes cast, motion carried.

At 7:03 p.m. Councilwoman Lewis arrived.

Consent Agenda:

A motion was made by Supervisor Bettez to approve and/or authorize the following as part of the consent agenda. Seconded by Councilman Torres, all aye votes cast, motion carried.

Discussion-2023 Budget

The current tentative budget reflects a 7.9% increase. Supervisor Bettez reviewed a list of proposed changes and cuts.

A motion was made by Supervisor Bettez to schedule the public hearing on the budget for November 3, 2022, at 7 p.m. Seconded by Councilwoman Seyfert-Lillis, all aye votes cast, motion carried.

A motion was made by Supervisor Bettez to adopt the proposed changes to bring the increase down to 5.63%. Seconded by Councilwoman Baer, all aye votes cast, motion carried.

Warrant:

A motion was made by Supervisor Bettez to adopt the October Warrant in the amount of \$2,851,823.81. Seconded by Councilman Torres, all aye votes cast, motion carried.

Authorization to advertise:

A motion was made by Supervisor Bettez to authorize Chris Marx to advertise for a full-time Buildings & Grounds Worker. Seconded by Councilman Torres, all aye votes cast, motion carried.

Discussion with Judge regarding budget:

Judge Weires joined the Board for a discussion regarding the Court's difficulties getting Court Officers mostly due to the rate of pay, and its need for another Court Clerk. Supervisor Bettez explained that the Town has had a lot of turnover recently and that the Board plans to address wages during the upcoming Union negotiations in an attempt to prevent further turnover.

At 7:49 p.m. a motion was made by Supervisor Bettez to adjourn the meeting. Seconded by Councilman Torres, all aye votes cast, motion carried.
