AGENDA ITEMS:

1. Mountain Rest Road repaving concerns:

Janelle: it has become more treacherous. It's smooth, but it has more height. Now there's a significant drop-off. And the fog line is even closer to the drop-off.

Why didn't we have a voice concerning this repaving?

Solution: move in the fog-lines? Other traffic calming measure?

Paint sharrow / bike in lane | stencils are in town possession.

Judy: regulation in place that nonmotorized transportation must be factored in on any repaving. Judy: state legislation or regulation? Check with Jen Metzger.

- 2. Water street / Carmine Liberta intersection:
 - a. Janelle: there should be signage telling cyclists they are permitted to ride the sidewalk over the bridge.
 - b. Mark: what about a Shivertown-like blinking light at this dangerous intersection?
- 3. Tim: add to the list to ask about the flags being removed from the crosswalk by Water Street Market at Main Street. Also ask about radar speed signs.
- 4. Potential of **meeting in person** with a Zoom option: we continue to be allowed to meet via Zoom and will do so for the foreseeable future.
- 5. Micro-transit possibility: Janelle will update on the status of this. Lots of optimism.
- 6. Where's the infrastructure and other flush funding at the local level? Ask Tim / Neil
- 7. **Radar speed signs**: any updates?

- a. Concerns about the limited hours of operation of radar flashing signs
- 8. Lower the speed limit in front of the high school. We can draft a letter to our local officials. Ask for flashing sign, in-street crosswalk sign, island in middle (yellow safety zone).
- Request for in-street crosswalk sign at Ridge Apartments / 32S. Request for more police enforcement of motorists failing to stop for pedestrians at crosswalks. Missing in-street crosswalk signs at Plattekill / S. Oakwood Terrace as well as River to Ridge trailhead at Springtown Road.
- 10. Request for more information from the county officials about speeding up the construction of **shoulders on Route 299** from Butterville Road to Route 44/55?

Neil: the NYS Department of Transportation is very sensitive about right of way (ROW). The NYS Department of Transportation will remove all funding for a project if there's any accusation about corrupt/inappropriate behavior.

ROW takes years. It's going to take a long time.

11. Steve: legislative session will soon end. One provision would be to permit lowering of speed limits. Neil: Bike/Ped should write Kevin Cahill a letter. Ask him to support it. If he won't ask why. Ask him to be a co-sponsor.
