At 7:01 p.m. a motion was made by Supervisor Bettez to open the public hearing on proposed local law #3 "Landlord and Tenant." Seconded by Councilman Irwin, all aye votes cast, motion carried.

At 7:04 p.m. a motion was made by Councilman Torres to close the public hearing. Seconded by Councilman Irwin, all aye votes cast, motion carried.

At 7:04 p.m. a motion was made by Trustee Young to open the Joint Town and Village Board meeting. Seconded by Trustee Murray, all aye votes cast, motion carried.

At 7:04 p.m. a motion was made by Supervisor Bettez to open the Joint Town and Village Board meeting with the pledge. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Agenda:

A motion was made by Trustee Tobin to adopt the agenda as amended. Seconded by Trustee Young, all aye votes cast, motion carried.

Public Input:

Matt Goodnow, Chief of the New Paltz Rescue Squad, gave an update regarding the number of calls for 2018 which totaled 2,412 with a 98.9% coverage rate, and how the agency currently operates. Ted Reis, President of the New Paltz Rescue Squad, announced that Chief Goodnow and the NPRS received awards from the Bureau of EMS.

Jonathan Bix, Executive Director and Co-founder of "Nobody Leaves Mid-Hudson"; Diana, UC Organizer, Margaret Veve and Klaus Yoder all expressed support for the issuance of Municipal IDs by the Town.

Presentation:

Ingrid Haeckel, Chair of the EnCB, gave a presentation on the Proposal to establish Critical Environmental Areas for the Town. She explained that if designated by the Town Board, it would not be creating a new code or law, rather it would encourage the Planning Board to take a more focused look at applications for larger projects such as subdivisions, non-residential facilities greater than 4,000 sq. ft. and the alteration of 10 acres of land or more. These designations, if established would become part of a statewide DEC map.

Municipal parking on Huguenot Street:

Supervisor Bettez explained that the County had previously expressed interest in sharing the cost to fund the redesign and restructuring of the lot at the Village Wastewater Treatment Plant, to allow for almost double the parking. County Legislators Hector Rodriguez and Jim Delaune explained that funds were included in a particular budget line with no specific project named. Those funds were moved into Contingency but can be moved back once the program guidelines have been established. Mr. Rodriguez and Mr. Delaune will continue to work on this.

Municipal IDs:

There was a discussion between the Town and Village Boards and Jonathan Bix regarding how the program would work. He explained that the larger surrounding cities including Kingston, Beacon, Poughkeepsie and Middletown have started issuing municipal ids to people unable to obtain government-issued identification. There was concern regarding the extent to which the ids would

be recognized by other entities. The program would be run out of the Clerk's office, which would require certain equipment and software. The Town will continue to work on this.

A motion was made by Councilman Irwin to adopt the resolution calling the public hearing for April 18, 2019 at 7:10 p.m. Seconded by Councilman Brownstein, all aye votes cast, motion carried.

Third Amendment to the Agreement between the City of NY and Town of New Paltz

A motion was made by Supervisor Bettez to authorize the Supervisor to sign the Third Amendment to the Agreement between the City of New York and the Town of New Paltz, New York, for the Design of Two Groundwater Systems. Seconded by Councilman Torres, all aye votes cast, motion carried.

Youth Center Van Purchase:

A motion was made by Councilman Brownstein to authorize buying the van for the New Paltz Youth Program in an amount up to \$6,000 from Contingency and allow them to re-pay it as soon as possible. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Authorization to charge Capital Fund:

A motion was made by Supervisor Bettez to pay Alfandre Architecture for architecture and planning services in an amount not to exceed \$8,500 out of the Capital Fund-Municipal Renovation account. Seconded by Councilman Irwin, all aye votes cast, motion carried.
