Trustee Rhoads stated that one of the trees planted by the Shade Tree Commission with the assistance of Chris Marx and others was stolen from Moriello Park.

Trustee Rhoads also announced the Shade Tree would be planting three Chestnut Trees at Moriello Park.

Trustee Rhoads announced that the Highway Department and the DPW will have a small, tree storage at the landfill.

Trustee Basco stated that this past Saturday, October 19th was Make a Difference Day and the Village had 26 volunteers from the SUNY campus come and help clean up the Village. Trustee Basco stated that the volunteers did a street clean up, they scrapped stickers from signs, they painted the gazebo in Hasbrouck Park.

Trustee Rhoads moved to have the Village Board hire Curt Lavalla as the Consultant Planner to implement the Joint Comprehensive Plan agreed to by both Boards at a compensation of \$1,000.00 per week pending a contract is drawn with Mr. Lavalla and that the insurance question is resolved and that this contract is not to exceed 52 weeks.

Mr. Rocco seconded for the purposes of discussion.

Mayor West requested it to be noted that this is not how the Village usually hires its contractors. Mayor West noted that usually contractors are paid 25% to 50% up front and then the remainder is usually paid at the completion of the work and not as a weekly payment. Mayor West also questioned how this would affect the unemployment insurance Mr. Lavalla is currently receiving from the Village.

Trustee Rocco offered a friendly amendment to the motion made by Trustee Rhoads that states:

Therefore be it resolved that the mayor and treasurer are authorized and directed to allocate \$18,000.00 from a combination of "Consolidation Funds" and /or the unused portion of the salary and benefits of the full-time planner and that these funds be distributed to the Town of New Paltz for this purpose as follows:

25% by October 30, 2013.

25% by January 31, 2014 after an interim report of progress has been received by the Village Trustees;

25% by March 31, 2014 after a second interim report of progress has been received;

25% by May 30, 2014 with the understanding that the remaining \$8,000 of the \$26,000.00 will be allocated in the new fiscal year and that both a third interim report will be forthcoming and a serviceable draft comprehensive plan will be provided to the Village and Town Boards by October 30, 2014.

Trustee Rhoads accepted Trustee Rocco's friendly amendment.

Trustee Rhoads amended the motion that the first payment is effective for November 15, 2013.

Trustee Rhoads amended her motion on the advice of Village Council so that the Consultant would be carrying the required insurance and producing the insurance documentation both to the Village and Town Boards and to the satisfaction of the Town and Village Boards.

3 Ayes. 2 Nays, Mayor West and Deputy Mayor Rotzler. Motion carried.

Councilman Barry moved to hire Curt Lavalla on behalf of the Town of New Paltz as a consultant on a non-exclusive basis to provide Planning Services to the Town and Village of New Paltz for a one year period to develop a Joint Master Plan at a cost of \$26,000.00 to the Town of New Paltz and the terms of which will be incorporated into a more formal agreement to be approved by the Town Board. Councilman Logan seconded. 5 Ayes. Motion carried.

Village Attorney, Joseph Eriole clarified for both Boards that there would still be a need for an inter-municipal agreement between the Boards.

Councilman Barry requested on behalf of the Town of New Paltz, would Mr. Eriole please draft the inter-municipal for both the Town and Village boards.

RESOLUTION TO ENTER INTO A CONTRACT WITH NEW YORK CITY DEPARTMENT OF ENVIRONMENTAL PROTECTION TO SEARCH FOR A WELL WATER SOURCE

WHEREAS the Village obtains it water primarily from the New York City Catskill Aqueduct; and

WHEREAS, the Village has been advised by the City of New York that because of planned improvements to the aqueduct commencing in the Fall of 2016 that the aqueduct will be shut down for a period of up to ten weeks; and

WHEREAS, the Village, in conjunction with New York City and its Department of Environmental Protection, is seeking alternative water sources for the use of the Village not only for the specific planned shutdown period but also for future backup and emergency sources of water for the use of its citizens as well as all those who obtain their water from the Village; and

WHEREAS, one of the primary possibilities for satisfying the need for backup water sources for the Village is to search for, discover and thereafter develop water wells within an area close to the existing Village water system, and

WHEREAS the New York City Department of Environmental Protection has agreed to fund a search for such water sources to commence immediately and such agreement has been memorialized in a proposed contract which will provide \$600,000 to the Village for that purpose;

NOW THEREFORE BE IT RESOLVED that the Mayor is hereby authorized and directed to sign that contract subject to final approval as to form and content by Special Counsel for the Village.
