Public Hearing-Repeal Ch. 34, "Police Commissioners, Board of" Town Board Workshop Meeting January 16, 2014 7:15 p.m.

Present: Supervisor Susan Zimet, Councilwoman Jean Gallucci, Councilman Dan Torres, Councilman Jeff Logan. **Absent**: Councilman Kevin Barry.

At 7:15 p.m. a motion was made by Councilwoman Gallucci to open the Public Hearing on the Repealing of Chapter 34 with the pledge. Seconded by Councilman Logan, all aye votes cast, motion carried.

Public Comment:

Justin Holmes is looking for a better understanding of what's going on. There seems to be a general lack of moral authority on this matter. He does not feel that Police Officers should be carrying tasers or semi-automatic weapons. Where does the Town Boars stand on this?

Amanda Sissenstein has concerns and questions about the Town Board overseeing the Police. Could it overburden the Board? She would feel more comfortable with complaints going to a committee made up of community members.

Mike Zierler indicated that this item was not on the agenda for the December meeting. It was added at the last minute with only three Board members present, and that looks bad. The Police Commission serves an essential job and an independent body is likely the way to go.

Butch Dener indicated that he was not here to defend the Commissioners, but to defend the *idea* of the commission. Police Officers need to be free of political agendas and interference.

Ariana Basco feels that the Commission is an important part of our community. It provides hands-on oversight with things like complaints. She hopes the Town Board does not repeal the chapter, but improve and restructure what already exists.

Stephanie Gibson emailed the following statement and requested that it be read aloud: As a 19-year resident and homeowner, I object to the Town Board's decision to dissolve this commission. According to published articles, Mr. Logan is on record as far back as Dec. 2011 with this exact same agenda. We the townspeople need our neighbors and peers to have this oversight. I firmly believe that the police commission is an absolute necessity to keep certain members of the Board honest.

Peter Savago spoke in favor of abolishing the Commission. He feels as though the Town Board is doing the right thing.

Mike Russo feels as though the decision has already been made. The Commission has done a number of helpful things including raising the issue of estimates that Wilmorite was claiming for Police Services. He hopes the Town Board will reconsider this decision.

Scott Schaffrick, Police Officer for the Town of New Paltz indicated he was not speaking on behalf of anyone but himself. The Police Commission adds a layer of bureaucracy, which creates a filtering issue that comes up frequently. There needs to be a degree of separation He is not against the Commission but feels there are some issues that need to be addressed.

A motion was made by Councilwoman Gallucci to close the Public Hearing. Seconded by Councilman Logan for discussion. Councilwoman Gallucci made a friendly amendment to close the Public Hearing but to accept written comments for five (5) days, until January 21st. Councilman Logan accepted the friendly amendment. All aye votes cast, motion carried.

A motion was made by Councilwoman Gallucci to adopt the agenda as amended. Seconded by Councilman Torres, all aye votes cast, motion carried.

Public Input:

Howard Miller indicated that the back of his home is on H.W. DuBois Rd., and it is dangerous to cross the street because there are a lot of people who speed going up to the stop sign at Prospect.

Peter Savago is here on behalf of the VFW and the American Legion. He is requesting that the Town Board increase the exemption amount for Veterans from \$45,000 to \$60,000, which is the County's current amount. Supervisor Zimet indicated that this is on the agenda for next week.

Joan Bender read aloud comments relative to the soil testing that was conducted for the Park Point project. The tests revealed levels of arsenic and PCB's. Tax payers should not be put at risk.

Andi Bartczak indicated that the Town Board should start the process of determining which non-profits should be paying taxes.

Irwin Sperber was happy to hear about the reconstitution of the ICIB. Feels that everyone should be paying their fair share of taxes.

At 8:51 p.m. a motion was made by Councilwoman Gallucci to go into Executive Session for the purposes of client-attorney discussion relative to Park Point. Seconded by Councilman Logan, all aye votes cast, motion carried.

At 10:20 p.m. a motion was made by Councilwoman Gallucci to come out of Executive Session. Seconded by Councilman Logan, all aye votes cast, motion carried.

Safety Program-As part of the Re-Org Meeting:

A motion was made by Councilwoman Gallucci to adopt the following Safety Program policy: All New Paltz Town offices that need to comply with PESH guidelines for MDA postings will begin the process of converting paper postings to electronic record keeping. Seconded by Councilman Logan, all aye votes cast, motion carried.

Clearing and Grading	\$250.00 base fee, plus \$125.00 for each additional meeting after the first two meetings, plus \$150.00 for each site visit required by the Planning Board Engineer.

Revised IMA-Master Plan Consultant:

Town and Village previously approved the IMA as a resolution then changes were made to the way the payment to the consultant was to be made. Before the first payment can be made in full, the Town bookkeeper needs a fully executed copy of the IMA that indicates that Town will make the payments and bill the Village for half. The January Warrant includes a payment to the consultant for \$5,000. The other \$5,000 will be issued outside the Warrant once the fully executed IMA is received.

A motion was made by Councilwoman Gallucci to authorize the Supervisor to sign the resolution to commence the Joint Comprehensive Plan payment to the planner and to add the date of signatures. Seconded by Councilman Torres, all aye votes cast, motion carried.

Greenway Grant:

The Town received a grant for the New Paltz Flats Trail Project. A motion was made by Councilman Torres to authorize the Supervisor to sign the grant. Seconded by Councilwoman Gallucci, all aye votes cast, motion carried.

Community Partnership Grant:

A motion was made by Councilman Logan to authorize the Supervisor to sign the grant. Seconded by Councilman Torres, all aye votes cast, motion carried.

Loop Bus Contract:

A motion was made by Councilwoman Gallucci to authorize the Supervisor to sign the contract for the fuel that SUNY contributes. Seconded by Councilman Logan, all aye votes cast, motion carried.

Rescue Squad Contract-For Ambulance Services:

Will be discussed next week pending some revisions.

<u>USIA Video Contract for Public Access Videographer and Coordinator:</u>

A motion was made by Councilman Logan to approve the contracts for the Public Access Videographer and Coordinator with USIA Video. Seconded by Councilman Torres, all aye votes cast, motion carried.

Filming of UCIDA Public Hearing:

A motion was made by Councilman Logan for the Town to pay for the filming of the UCIDA's Public Hearing on Park Point on January 28th at the High School, at a cost of \$195. Seconded by Councilman Torres, all aye votes cast, motion carried.

Personnel:

A motion was made by Councilman Logan to change Adrian Jacob from part-time to full time at the Recycling Center at a rate of \$15.61/hr. He was previously hired by the Town Board on December 19th for a one-month trial period. Seconded by Councilman Torres, all aye votes cast, motion carried.

Warrant:

A motion was made by Councilwoman Gallucci to approve the January Warrant pending the appropriate year-end correcting journal entries that are needed. Seconded by Councilman Logan, all aye votes cast, motion carried.

At 11:14 p.m. a motion was made by Councilwoman Gallucci to adjourn the meeting. Seconded by Councilman Logan, all aye votes cast, motion carried.
