# Joint Town & Village Meeting December 6, 2018 7 p.m.

At 7:20 p.m. a motion was made by Supervisor Bettez to open the joint meeting with the pledge. Seconded by Councilman Irwin, all aye votes cast, motion carried.

<u>Agenda</u>: +Village Board approval of 11/14/18 Joint Minutes, +Town Board approval to extend deadline for open enrollment, +Approval of 2<sup>nd</sup> Proposal from Alfandre Architecture, +Town Board approval to set amount for green project reserve fund.

A motion was made by Supervisor Bettez to adopt the agenda as amended. Seconded by Councilman Torres, all aye votes cast, motion carried.

# Public Comment:

Edgar Rodriguez, Tanya Marquette and Kevin Kelly spoke about the incident involving the Police Department and Paul Echols.

# Presentation:

Rebecca Minas of Barton & Loguidice presented the Town and Village Boards with a Draft New Paltz Green Infrastructure Capital Improvements Feasibility Plan. This plan was developed to assist the Town and Village in moving forward with their desire to advance a Green Infrastructure program. The Town and Village Boards will forward any questions and comments to Ms. Minas.

# Proposal for a Joint Town-Village Website:

Supervisor Bettez indicated that the lowest proposal came in at \$11,000. Mayor Rogers indicated that the Village has a Fiber connection which would allow the Village to host a website on its' own server. The Boards will continue to work on this with a decision anticipated to be made by December 20<sup>th</sup> in order to meet the Town's deadline with its' current website company.

# Discussion of Draft Law:

The Boards discussed amending and/or striking certain language in the draft law, "Loitering for the purpose of using or possessing marijuana or a controlled substance". It will be sent to agencies and/or individuals who have been involved in the process, for review and discussed at a future meeting.

# Review of Proposal from Alfandre Architecture for a Joint Municipal Center:

A motion was made by Councilman Irwin that the Supervisor is hereby authorized to execute Alfandre Architecture's agreement captioned "Second proposal for architecture and planning services", in an amount not to exceed \$8,500, upon review and mutual approval by both the Supervisor and Councilman Irwin. Seconded by Supervisor Bettez, with support from the Village Board. All aye votes cast, motion carried.

At 9:01 p.m. Trustee Kerr left the meeting.

# Joint Resolution:

A motion was made by Mayor Rogers and Supervisor Bettez to adopt the following resolution: Authorizing a Collaborative Unified Planning Work Program Application to Ulster County Transportation Council Led by the Town of New Paltz in Collaboration with the Village of New Paltz for a Complete Streets/ Pedestrian and Bicycle Strategic Plan

WHEREAS, the Town and Village are interested in working jointly on comprehensive, integrated transportation planning as well as cooperating with regional and state officials and other locally interested parties on transportation planning; and WHEREAS, the purpose of a bicycle-pedestrian plan is to develop a more walkable and bikeable community, preparing improvements to physical infrastructure that aids and equips pedestrian and bicycle travel by residents and visitors, while also fostering supporting policies, all of which will help expand safe connections between locations and land uses like SUNY-New Paltz and Main Street and the Empire State Trail, as well as to major employers within the community, and to schools, building on prior efforts like the Land Use Transportation Study and the Safe Routes to School Plan, and; WHEREAS, the joint Village and Town Bicycle Pedestrian Committee indicates support for this Project which can enable multimodal infrastructure enhancements and capacity for these groups, elected leaders and other interested persons and groups to strengthen the culture of walking and bicycling, and help provide balanced and sustainable transportation; and **WHEREAS**, a pedestrian and bicycle plan can assist overall economic development, making the village and town more bicycle-friendly, fostering less reliance on autos, and aiding landowners by not having to over-supply parking which is costly, while also helping relieve the impacts of congestion, such as experienced on many peak weekends; and **WHEREAS**, a bicycle-pedestrian plan can provide for long-range policy and coordination of resources at the same time as the community takes on complimentary implementation projects, to support and complement the establishment of the Empire State Trail and advance potential pedestrian safety improvements; now therefore

**BE IT RESOLVED** that the New Paltz Town Board supports the Town's submission to Ulster County Transportation Council of a 2018/2019 Unified Planning Work Program application for the UCTC to lead the establishment of a joint New Paltz Complete Streets/ Bicycle Pedestrian Plan project as part of the upcoming UPWP.

Seconded by Trustee Murray and Councilman Torres, all aye votes cast, motion carried.

This amendment would prohibit ICE or CBP officials from arresting a person on Town Court property. This is in response to the recent arrest of Matthew Rojas. Councilman Torres will continue to work on this and speak to the appropriate authorities as to the legality of this amendment.
