Town Engineer, Dave Clouser explained that this is a proposed improvement of the facilities serving Town Water Districts 1, 2 and 3, consisting of the installation of a water line that will connect the water tank supplying those districts and the water main on South Putt Corners Road to improve flow and pressure to all district users, at an estimated maximum cost of \$175,000 including incidental expenses incurred in connection with that work.

Miriam Strouse and Iris Bloom indicated that they appreciate the leadership in opposing the Pilgrim Pipeline.

Kevin Borden and Dennis Moore, Chair of CWOSP, urged the granting of a conservation easement for the Millbrook preserve and its' importance to the protection of the Preserve and Open Space. Joel Oppenheimer, Gardiner, indicated that he supports the Overlay District and potential Moratorium.

Amy Cohen, on behalf of herself, read aloud a statement regarding the Cusanno Annexation and requested the Town Board pass a resolution requiring all Boards and Commissions to recite the pledge at their meetings.

Mike Zierler, on behalf of himself, read loud a statement regarding the Cusanno Annexation and the reciting of the pledge at meetings.

# **Improvements to Water Districts 1, 2 and 3:**

Town Engineer Dave Clouser explained Parts 1, 2 and 3 of the Short Form EAF for the South Putt Corners Road Water Main Connection.

A motion was made by Councilman Logan to adopt a Negative Declaration under SEQR, as the proposed action will not result in any significant adverse environmental impacts. Seconded by Councilman Torres, all aye votes cast, motion carried.

# New Paltz Wallkill River Rail Trail Signage Program:

The Short Form EAF was prepared by Dave Clouser. A motion was made by Supervisor Bettez to adopt a Negative Declaration under SEQR for the Wallkill Valley Rail Trail Signage Project, as the proposed action will not result in any significant adverse environmental impacts. Seconded by Councilman Irwin, all aye votes cast, motion carried.

# **Moriello Water Line Easement (South Putt Corners Road):**

A motion was made by Councilman Logan to authorize the Supervisor to sign the Waterline Easement Agreement between the Town of New Paltz and J.A.M of New Paltz. Seconded by Councilman Irwin, all aye votes cast, motion carried.

**WHEREAS**, as part of that process, Clouser Engineering intends to assign such contracts and other agreements to Barton & Loguidice and Barton & Loguidice has agreed to assume and perform all obligations of Clouser Engineering required to be performed under all such contracts and other agreements with the town on and after the effective date of the assignment(s) which is anticipated to be on or about March 1, 2016; and

**WHEREAS**, it is intended that David Clouser, P.E. shall continue to be the engineer primarily responsible to the town on behalf of Barton & Loguidice for the performance of such engineering services; and

**WHEREAS**, Barton & Loguidice have offered a certain "Consent to Assignment of Contract" in the form attached;

**NOW, THEREFORE,** be it:

#### Mill Brook Preserve:

Councilman Irwin read aloud the following statement:

"For the record, I've previously stated that I am a volunteer on the Wallkill Valley Land Trust's Conservation Committee. To further clarify, as a volunteer, I'm not a member of the Trust, I cannot vote-only participate in any discussions at Conservation Committee meetings. Under their ethics rules, I can't be in the room during any discussions regarding Mill Brook Preserve. I've also learned from Christie DeBoer, the Trust's Executive Director, that it is their Executive Committee that votes whether to accept Conservation Easements. So I have no direct or indirect pecuniary benefits in this capacity."

Councilman Irwin presented to the Board a draft "Resolution to place a conservation easement on Town lands, which are, and are to become, part of Mill Brook Preserve and to use 2006 Open Space Bond Act Funds to pay for costs associated therewith." This was followed by a discussion regarding the differences between and the pros and cons of Parkland Designation vs. Conservation Easement.

This item was tabled further discussion.

# **Proclamation-Parkinson's Awareness Month:**

A motion was made by Councilman Irwin to declare April Parkinson's Awareness Month in 2016. Seconded by Councilman Logan, all aye votes cast, motion carried.

# **Pilgrim Pipeline-Response to DEC:**

Councilman Torres made reference to a document sent by Fran Wishnick entitled "Land Use Moratorium." Councilman Logan briefly discussed past moratoriums. During the discussion, Councilman Torres indicated that he would like to see workshop sessions with the Planning Board.
