Public Hearing-Van Tassell/Cusanno Annexation, 7:15 p.m. Town Board Meeting, 7:30 p.m. April 21, 2016

<u>Present</u>: Supervisor Neil Bettez, Councilman Dan Torres, Councilwoman Julie Seyfert-Lillis, Councilman Marty Irwin. <u>Absent</u>: Councilman Jeff Logan.

At 7:15 p.m. a motion was made by Councilman Torres to open the Public Hearing on the Petition for Annexation by Dean Van Tassell at 152 Route 32 North.

Public Comment:

Josh Honig asked if the Town has received a proposal or plans for the project at the proposed annexation property. Councilman Torres indicated that the Town has received conceptual drawings. Mr. Honig also asked if an analysis of benefits to Town Tax Payers was ever done on this project to determine how it will affect them.

Josephine Bloodgood, Miriam Strauss, MaryJo Johnson, Craig Shankles and Ann Fowler commented on the proposed annexation and requested that the Town Board hold off on making any decisions on this.

The Town Board agreed to continue the Public Hearing on April 28th at 7:15 p.m.

At 7:36 p.m. a motion was made by Councilman Torres to open the Town Board meeting with the pledge. Seconded by Councilman Irwin, all aye votes cast, motion carried.

Reimbursement for Drainage Easement Costs:

Tabled. Councilman Torres was concerned with setting a precedent. He would like to seek the Attorney's advice before proceeding.

Public Comment:

Josh Honig commented on the possibility of a single attorney representing both the Town and Village Planning Boards.

Karl Conboy, Dean Trigoris, Andrew Mironchik and John Wenig, members of VFW Post 8645 in New Paltz, and Ira Margolis commented on the issue regarding the reciting of the pledge at meetings.

Peter Kaufman, Katherine Stewart, Susan DeMark, Maryann Losee, Kevin Borden, Joel Oppenheimer, Don Kerr, and Donna Bruschi requested the Town Board adopt a temporary moratorium and overlay district on the Gateway Corridor.

Discussion of Building Moratorium:

Susan Blickstein, Town resident and Planner, discussed the process and purpose behind moratoria and how they impact the planning process.

A motion was made by Councilman Torres to create a subcommittee to further explore a moratorium for the Gateway District and to make a recommendation to the Town Board. The subcommittee will consist of a member of the Historic Preservation Commission, the Planning Board, the Bike-Ped Committee, the Environmental Conservation Board, Susan Blickstein as the Chair, and Councilwoman Seyfert-Lillis as the Town Board Liaison. Seconded by Supervisor Bettez, all aye votes cast, motion carried.
